97-548A AGENDA

In accordance with the Open Meeting Law, on motion by Commissioner Bond, seconded by Commissioner Mouliot, which motion duly carried, Chairman Sims ordered that the agenda for the May 27, 1997, meeting be approved with the following amendments: Delete Item 6F, consideration of unbudgeted capital outlay for Sparks Justice Court to purchase a postage machine; and to hear the Legislative Update immediately after Public Comments.

PUBLIC COMMENTS

There was no response to the call for public comments.

97-548 LEGISLATIVE UPDATE

Mary Henderson, Government Affairs Director, updated the Board on legislative matters, specifically SCR40 concerning the tax study, the Constable bill, and the Sheriff's substation legislation.

Legal Counsel Madelyn Shipman reviewed the County's water bill detailing the remediation district legislation stating that the language currently proposed clearly gives the County Commission the discretion to look at how properties will be benefited when determining fees, as well as methods for dealing with contaminators. The Board expressed its unanimous support for this bill.

Ms. Henderson also explained what is occurring on AB291, the sales tax/infrastructure bill. In response to Chairman Sims, she explained that the currently proposed language gives the County Commissioners the flexibility to impose the tax with or without seeking a vote of the people. Except for Commissioner Galloway, the Board endorsed the concept of this legislation. Commissioner Galloway stated that he feels the legislation should require a vote of the people.

THE BOARD CONVENED AS THE BOARD OF TRUSTEES FOR THE SIERRA FOREST FIRE PROTECTION DISTRICT

97-549 FY 1997/1998 FINAL BUDGET - SIERRA FOREST FIRE PROTECTION DISTRICT (continued from May 20, 1997)

9:30 a.m. This time was set in a continuation of Public Hearing to consider final adoption of the Fiscal Year 1997/98 Budget for the Sierra Forest Fire Protection District.

Chairman Sims stated that the proposed budget includes a 3-cent tax increase to cover salary increases imposed by the State and that it has been approved by the other counties involved.

Commissioner Bond noted that although the salary increases are significant, these firefighters will still be below Truckee Meadows personnel and other fire districts. She also stated that the Commissioners have been criticized for not taking tax increases to the people and asked if there is any way to change these procedures to let the people impacted know. Jerry McKnight, Budget Coordinator, advised that this hearing is part of the public process and was advertised as such in the newspaper. He further advised that these salary increases have been approved by the State; that those increases will be paid regardless of what action Washoe County takes; and that if the 3-cent increase is not approved, the District will be forced to reduce service levels.

Bob Ashworth, Western Regional Forester, provided additional information concerning staffing and service levels.

Chairman Sims called on anyone wishing to speak concerning the Sierra Forest Fire Protection District budget. There being no response, the public hearing was closed.

On motion by Commissioner Bond, seconded by Commissioner Mouliot, which motion duly carried, Chairman Sims ordered that the Fiscal Year 1997/1998 Budget for the Sierra Forest Fire Protection District, including the tax rate increase based on State mandated salary increases, be adopted.

97-550 FY1997/1998 FINAL BUDGET - WASHOE COUNTY (continued from May 20, 1997)

Pursuant to questions at Caucus, Joanne Ray, Personnel Division, explained which County departments currently utilize the 4-10's workweek or other flexible schedules and the reasons for doing so. Commissioner Galloway expressed his opposition to varying work schedules.

Bob McGowan, County Assessor, stated that his staff is already working 4-9's and 1-4 and that they would like to try a 4-10 workweek on a 5-month trial basis. He emphasized that the employees' schedules will be at the discretion of the supervisors; that the office and phones will be covered during all normal business hours and even beyond those hours; and that the main goal they hope to attain is more on-line time when other employees are not at work and the computer system is not so busy, as well as expanding service to the taxpayers.

Following further discussion, on motion by Commissioner Shaw, seconded by Commissioner Mouliot, which motion carried by a 3 to 1 vote with Commissioner Galloway voting "no," and Chairman Sims being temporarily absent, Vice Chairman Bond ordered that the request by the Assessor to offer his staff a 4-day workweek at 10 hours per day, on a trial basis until October 24, 1997, be approved.

97-566 APPOINTMENT OF DIRECTOR OF THE DEPARTMENT OF WATER RESOURCES

Upon recommendation of John MacIntyre, County Manager, on motion by Commissioner Mouliot, seconded by Commissioner Shaw, which motion duly carried, Vice Chairman Bond ordered that Steve Varela be appointed as Director of the Department of Water Resources at an annual salary of \$87,401 effective July 7, 1997.

97-567 SUBORDINATION AGREEMENT - NORTHWEST NEVADA WATER RESOURCES, LTD./FISH SPRINGS RANCH

John MacIntyre, County Manager, stated that this item was discussed at Caucus, at which time Legal Counsel Madelyn Shipman advised that

subrogation of the County's interest in the Deed of Trust with Northwest Nevada Water Resources, Ltd., would not put the County at risk.

On motion by Commissioner Mouliot, seconded by Commissioner Shaw, which motion duly carried, Vice Chairman Bond ordered that a Subordination Agreement between Washoe County and Northwest Nevada Water Resources Ltd. and Fish Springs Ranch concerning subrogation of the County's interest in a Deed of Trust be approved and Chairman Sims be authorized to execute.

97-568 REFUND OF FEES PAID TO ROAD DIVISION - FILL MATERIAL - RANCHO HAVEN PROPERTY OWNERS ASSOCIATION

Vice Chairman Bond provided background information stating that this is one of many private organizations that does the road maintenance on the roads in their neighborhoods, but the roads are actually public roads.

Commissioner Galloway suggested that perhaps the County needs to establish a policy and set criteria to deal with this in the future.

On motion by Commissioner Mouliot, seconded by Commissioner Shaw, which motion duly carried, it was ordered that staff be directed to refund \$700 to the Rancho Haven Property Owners Association for the fill material they purchased from the County to repair damage to one of their roads.

97-569 BACKGROUND CHECKS POLICY AND PROCEDURES - PERSONNEL

Upon recommendation of Joanne Ray, Chief of Personnel, on motion by Commissioner Mouliot, seconded by Commissioner Bond, which motion duly carried, Chairman Sims ordered that the procedures concerning pre-employment background and reference checks outlined in the memorandum from Ms. Ray dated May 16, 1997, and placed on file with the Clerk, be adopted as Washoe County's Background Checks Policy and Procedures. It was further ordered that the Personnel Division be authorized to maintain and amend, when necessary, the list of classes to which the policy will apply.

97-570 AGREEMENT - KOINONIA FOSTER HOMES, INC. - EMERGENCY CHILD PROTECTIVE FOSTER HOMES - SOCIAL SERVICES

Upon recommendation of John Balentine, Purchasing and Contracts Administrator, on motion by Commissioner Bond, seconded by Commissioner Galloway, which motion duly carried, it was ordered that the Purchasing and Contracts Administrator be authorized to execute a non-exclusive agreement with Koinonia Foster Homes, Inc., for the provision of emergency child protective foster homes on an as-needed basis and at the contract rate of \$40.00 per day per child and \$56.66 per day for children with special treatment needs, for the period July 1, 1997, through June 30, 1998, renewable at the County's option in annual increments not to exceed two additional years, on behalf of the Washoe County Department of Social Services. It was noted that the estimated annual value of this agreement based on fiscal year 96/97 expenditures is \$250,000.00.

It was further ordered that the Purchasing and Contracts Administrator be authorized to execute non-exclusive agreements with other qualified individual foster care homes at the same contract rates as indicated above during fiscal year 1997/98 subject to renewal, as may be required by the Washoe County Department of Social Services.

It was noted that the County is currently contracting with 13 emergency foster care providers, including Koinonia Foster Homes, in the approximate amount of \$600,000.00 per year.

97-571 OUTSIDE AGENCY CONTRACTS - FORENSIC SERVICES FISCAL YEAR 97/98 - SHERIFF

Upon recommendation of Sheriff Richard Kirkland, on motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried, Chairman Sims ordered that the Sheriff's Office Forensic Science Division (Crime Lab) be authorized to enter into 22 Forensic Support Service Agreements between the County of Washoe (Sheriff) and the Sheriffs for the Counties of Carson City, Churchill, Douglas, Elko, Eureka, Humboldt, Lander, Lyon, Mineral, Pershing, Storey and White Pine; the Police Departments for the Cities of Elko, Fallon, Lovelock, Sparks, West Wendover, Winnemucca and Yerington; Nevada State Highway Patrol; Nevada Department of Motor Vehicles and Public Safety (NDI); and the Nevada Employment Security Department, concerning in-house laboratory analyses and field investigation.

97-572 AGREEMENT - NORTH LAKE TAHOE FIRE PROTECTION DISTRICT - DISPATCH SERVICES

John MacIntyre, County Manager, stated that extensive discussion was held on this item at the Caucus meeting and that staff has provided additional information concerning the total number of calls for service coming in to the dispatchers.

Commissioner Bond stated that she does not believe the numbers justify having 2 dispatchers per shift. Captain Jim Nadeau, Washoe County Sheriff's Office, explained that the numbers in the report reflect only the calls for service received from the public and does not include other law enforcement calls, general information calls from the public, etc.

Commissioner Mouliot explained that when a dispatcher receives a call for police, fire or EMT services, that dispatcher must then do many other things and is not able to take other calls until the particular situation is dealt with. County Manager John MacIntyre also stated that this consolidation is consistent with what the County has been trying to do to regionalize services.

Commissioner Shaw requested that the Board receive a progress report after the consolidation is completed.

Commissioner Shaw moved that the Interlocal Contract for Consolidated Communications Services between the County of Washoe and the North Lake Tahoe Fire Protection District, concerning provision of dispatch services by Washoe County for the North Lake Tahoe Fire Protection District, be approved and that Chairman Sims be authorized to execute on behalf of Washoe County. The motion was seconded by Commissioner Bond. Under discussion, Commissioner Galloway requested that the motion include reference to the clarification letter from the North Lake Tahoe Fire Protection District dated May 5, 1997 concerning negotiation for future rents. Commissioners Shaw and Bond agreed to so amend the motion. Upon call for the vote, the amended motion carried unanimously.

97-573 ANNEXATION AGREEMENT - RENO PARK WATER COMPANY COLD SPRINGS WASTEWATER TREATMENT PLANT (SPECIAL ASSESSMENT

DISTRICT NO. 21) - UTILITY DIVISION

Upon recommendation of John Collins, Utility Services Manager, on motion by Commissioner Bond, seconded by Commissioner Mouliot, which motion duly carried, it was ordered that the Annexation Agreement between Washoe County and Reno Park Water Company concerning water service to the Cold Springs Wastewater Treatment Plant being constructed as part of Special Assessment District No. 21 be approved and Chairman Sims be authorized to execute on behalf of Washoe County.

97-574 CHANGE ORDER TO AGREEMENT - FINANCIAL CONSULTING SOLUTIONS GROUP, INC. - WATER COST OF SERVICE STUDY - UTILITY DIVISION
