The Board met in regular session in the Commission Chambers of the Washoe County Administration Complex, 1001 East Ninth Street, Reno, Nevada. Following the pledge of allegiance to the flag of our Country, the Clerk called the roll and the Board conducted the following business:

#### 97-1086 AGENDA

In accordance with the Open Meeting Law, on motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried, Chairman Bond ordered that the agenda for the October 28, 1997, meeting be approved with the following amendments: Item 12A, possible appointment to East Washoe Valley Citizen Advisory Board is being continued, and it should be noted that the correct parcel number under Item 11, line 13, James C. and Wava M. Baker, TR., is 032-282-12.

### MINUTES

On motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried with Commissioner Mouliot abstaining because he was absent that day, Chairman Bond ordered that the minutes of the special joint meeting of October 8, 1997, with the Cities of Reno and Sparks, be approved.

### PUBLIC COMMENTS

There was no response to the call for public comments.

#### 97-1087 KENNEL PERMIT APPEAL - CONNIE DOWELL

Katie Stevens, Animal Control, reviewed background information concerning the kennel permit application of Connie Dowell requesting to keep eight dogs at 440 Ramsey Way in the Lemmon Valley area. Ms. Stevens and Officer Brown then answered Board questions specific to subject property.

Connie Dowell, applicant, stressed that it is not her dogs that are barking and described the fencing and kennels that she will build. She stated that her dogs have never been a nuisance; that she will not allow her dogs to be a nuisance; and that she would be willing to comply with whatever requirements are necessary for the Board to let her keep her dogs.

Bobbie Prather, Albert Way resident, spoke in support of Ms. Dowell receiving the kennel permit stating that her dogs are very well cared for and are not the dogs that are barking.

Board members asked several questions of staff regarding whether or not certain conditions could be placed on the kennel permit if granted and also of the applicant concerning when the fencing, kennels, etc., would be completed.

Following further discussion, on motion by Commissioner Mouliot, seconded by Commissioner Galloway, which motion duly carried, Chairman Bond ordered that a kennel permit for Connie Dowell to keep eight dogs at 440 Ramsey Way, Lemmon Valley, be granted subject to all of the regular Animal Control rules and regulations as set forth in the Washoe County Code and the following conditions:

- 1. Should the number of dogs be reduced, there will be no replacement dogs.
- 2. If there are continuing substantiated complaints that these dogs are a nuisance, the applicant may have to reappear before the Board and the Board may revoke the permit.
- 3. Staff is directed to do a 6-9 month review of the permit and present a status report to the Board.

### 97-1088 KENNEL PERMIT APPEAL - TERESA O'MEALIA

Katie Stevens, Animal Control, reviewed background information concerning the kennel permit application of Teresa O'Mealia requesting to keep four dogs at 3505 Meadowlark Drive in the Cold Springs area, noting that in this instance the application was received prior to there being any complaints concerning these dogs.

The applicant's mother and sister-in-law spoke on behalf of the applicant. Brenda O'Mealia read a written statement prepared by the applicant into the record and stated that they recently acquired the fourth dog after it was abandoned by one of their neighbors. In response to Board questions, Mrs. O'Mealia stated that someone is always home; that if the dogs do start barking, they are brought into the house immediately; and that the dogs are inside most of the time.

Ms. Stevens and Officer Brown then answered questions of the Board concerning subject animals and property.

Following further discussion, on motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried, Chairman Bond ordered that a kennel permit for Teresa O'Mealia to keep four dogs at 3505 Meadowlark Drive, Cold Springs, be granted subject to all of the regular Animal Control rules and regulations as set forth in the Washoe County Code and the following conditions:

- 1. If there are continuing substantiated complaints that these dogs are a nuisance, the applicant may have to reappear before the Board and the Board may revoke the permit.
- 2. Staff is directed to do a 6-9 month review of the permit and present a status report to the Board.

### 97-1089 KENNEL PERMIT APPEAL - JENNIFER L. WALSH

Katie Stevens, Animal Control, reviewed background information concerning the kennel permit application of Jennifer Walsh requesting to keep four dogs at 18020 Blackbird Drive in the Cold Springs area, noting that part of the delay in processing this application is that the applicants needed to obtain permission from their landlord, which has been obtained. She further stated that there has been some concern raised regarding the welfare of these dogs; that they are all on chains; that the officers have observed the dogs tangled up in their chains; and that if the Board grants the permit, the applicant will be required to provide kennels, which would probably be better for the dogs. Ms. Stevens and Officer Monroe then answered numerous questions of the Board.

Michael Walsh, applicant's husband, stated that putting a kennel right in front of their home should resolve all the problems and complaints. In response to the Board, Mr. Walsh stated that they do take care of their dogs; that sometimes the dogs spill their water; and that both he and his wife do spend time with the dogs when they can.

Following further discussion, on motion by Commissioner Mouliot, seconded by Commissioner Galloway, which motion duly carried,

- Chairman Bond ordered that the kennel permit for Jennifer Walsh to keep four dogs at 18020 Blackbird Drive be granted subject to all of the regular Animal Control rules and regulations as set forth in the Washoe County Code and the following additional conditions:
- 1. The female dog is to be spayed within 30 days and applicants will do everything in their power until then to prevent a litter of puppies.
- 2. Shelter from inclement weather and summer heat is to be provided for the animals.
- 3. If there are continuing substantiated complaints that these dogs are a nuisance, the applicant may have to reappear before the Board and the Board may revoke the permit.

It was further ordered that staff be directed to check on the welfare of these animals on a weekly basis making sure that they have food and water and that the kennels are kept clean; and, if not, citations into court will be issued.

### 97-1090 DONATION OF PREHISTORIC ARTIFACT TO NEVADA STATE MUSEUM

Upon recommendation of Dave Roundtree, Public Works Director, on motion by Commissioner Galloway, seconded by Commissioner Mouliot, which motion duly carried, Chairman Bond ordered that the donation of the prehistoric artifact "Crescent" to the Nevada State Museum be approved.

97-1091 WATER RIGHTS DEED AND WATER SALE AGREEMENT - SIERRA PACIFIC POWER COMPANY - GREEN PARCEL MAP

Upon recommendation of John Collins, Manager, Utility Services Division, Department of Water Resources, on motion by Commissioner Galloway, seconded by Commissioner Mouliot, which motion duly carried, it was ordered that the following actions be taken regarding dedication of water rights in support of the parcel map for J. Green, APN 009-252-01:

- 1. The Water Rights Deed between Sierra Pacific Power Company, as Grantor, and Washoe County, as Grantee, for 2.46 acre feet of surface water rights being a portion of Claim 153, be approved and Chairman Bond be authorized to execute;
- 2. The Water Sale Agreement between Sierra Pacific Power Company and Washoe County be approved and Chairman Bond be authorized to execute; and
- 3. The Utility Services Division Manager be directed to record the Water Rights Deed and Water Sale Agreement with the County Recorder.
- 97-1092 AWARD OF BID PUBLIC ACCESS COIN/CARD PHOTOCOPIERS RFP NO. 2022-98 LIBRARY

This was the time to consider award of bid, Notice to Bidders for receipt of sealed bids having been published in the Reno Gazette-Journal on August 5, 1997, for public access coin/card photocopiers on behalf of the Washoe County Libraries. Proof was made that due and legal Notice had been given.

Bids, copies of which were placed on file with the Clerk, were received from the following vendors:

IKON Office Solutions Skipco, Inc.

Hughes-Calihan and The Copy Man submitted "no-bid" responses; and American Press & Digital Products, Danka Industries, D.G.M. Copier Service, High Sierra Copier Service, Lockwood-Moore, Inc., Nevada Office Machines, Inc., and Sierra Office Solutions failed to respond to the invitation to bid.

Upon recommendation of John Balentine, Purchasing and Contracts Administrator, who was present to respond to Board questions and to explain the advantages of renting, rather than purchasing, the equipment, on motion by Commissioner Galloway, seconded by Commissioner Mouliot, which motion duly carried, Chairman Bond ordered that the proposal from Skipco, Inc., the most responsive,

responsible proposer, in response to RFP No. 2022-98 for rental of public access coin/card photocopiers for the Washoe County Libraries, be accepted.

It was further ordered that the Purchasing and Contracts Administrator be authorized to enter into a 48-month rental agreement commencing approximately November 17, 1997, through November 18, 2001, with Business Credit Leasing, Skipco's designated leasing company, for the rental of 13 Toshiba 2532 Turbo Copying Systems, at a rate of \$132.70/per month/per copying system, for a total agreement amount of \$82,804.80, and with each copying system including a Toshiba 1500 Sheet Letter Size Pedestal, ACD Multi-vend Coin Operating Device (coin only), and ACD Front Loading Locking Device.

It was further ordered that the Purchasing and Contracts Administrator be authorized to enter into a 48-month maintenance agreement commencing approximately November 17, 1997, through November 18, 2001, with Skipco, Inc., at a rate of \$36.30/per month/per copying system, for a total agreement amount of \$22,651.20, for the maintenance and supplies, excluding copy paper, for the 13 Toshiba 2532 Turbo Copying systems to be rented from Business Credit Leasing.

It was noted that the total dollar amount of both agreements for the 48-month period is \$105,456.00; and that the copiers will generate revenue approximated at \$28,600 annually.

It was further ordered that the Purchasing and Contracts Administrator be authorized to enter into a 2-year requirements agreement with the specified vendor for inmate uniform clothing, commencing November 1, 1997 through October 31, 1999, with a 2-year renewal option, provided vendor meets all pricing requirements agreed to in their original bid.

97-1109 COMPREHENSIVE PLAN AMENDMENT CASE NO. CPA97-F-01[A] (ADMINISTRATIVE CHANGES) AND APPEAL OF CPA97-F-01[B] (GARY SCHMIDT) - CONTINUATION OF PUBLIC HEARING

On motion by Commissioner Galloway, seconded by Commissioner Mouliot, which motion duly carried, Chairman Bond ordered that the continuation of the public hearing on Comprehensive Plan Amendment Case No. CPA97-F-01[A], Administrative Changes, and the appeal of CPA97-F-01[B], Gary Schmidt, originally scheduled for October 28, 1997, at 5:00 p.m. be continued to November 18, 1997, at 5:00 p.m.

Comprehensive Plan Amendment Case No. CPA97-F-01[A] (Administrative Changes) is the Washoe County Planning Commission's recommendation to approve the administrative changes on the land use map to redesignate federal lands not slated for disposal shown on the Open Space Plan from General Rural (GR) to Open Space (OS). The following parcels are proposed to be designated Open Space (OS): Assessor Parcel Numbers 041-030-02, 03, 04 05 and 09; Assessor Parcel Number 046-041-06; Assessor Parcel Number 046-051-07; Assessor Parcel Numbers 046-060-12, 13 and 22; Assessor Parcel Number 047-150-01; Assessor Parcel Numbers 048-010-01, 02, 03, 05, 06, 08, 10, 11, 12, 13, 14, 15 and 16; Assessor Parcel Numbers 048-020-01, 02, 03, 04, 07, 09, 11, 12, 14 and 15; Assessor Parcel Numbers 048-030-01, 02, 03, 04, 05, 07, 10, 11, 12 and 13; Assessor Parcel Numbers 048-041-04, 05, 06, 07, 08, 10, 11 and 12; Assessor Parcel Number 048-042-02; Assessor Parcel Numbers 048-061-01 and 03; Assessor Parcel Number 048-062-03; Assessor Parcel Number 048-112-08; Assessor Parcel Number 048-120-20 and 21; Assessor Parcel Number 055-010-01, 02, 03, 04, 05, 07, 08, 09, 12, 19, 20, 23, 24, 25, 38, 39, 40, 41, 43, 45 and 46; Assessor Parcel Number 055-110-01 and 02; Assessor Parcel Number 055-180-05; Assessor Parcel Numbers 055-301-12 and 13; Assessor Parcel Numbers 049-010-01, 02, 03, 14, 15, 16 and 19; Assessor Parcel Number 126-010-54; Assessor Parcel Numbers 126-020-02 and 03; Assessor Parcel Numbers 130-010-05, 06 and 07 and to consider Assessor

Parcel Number 047-150-03 held in public ownership and slated for disposal by the United States Forest Service. Additionally, administrative changes on the Public Services and Facilities Plan are proposed to remove public trails under the authority of Washoe County Park and Recreation plan.

Additional administrative changes are proposed to reintroduce the entire Forest Area Plan geographic information system map series to reflect the new department name and logo and any necessary changes as required by approval of all or any portion of the proposed amendment as well as appropriate text changes, including the revised table of land use acreage's to match the approved map changes. All the parcels under consideration are designated as "Suburban" on the Truckee Meadows Regional Plan land use diagram, therefore a Regional Plan amendment should not be required.

Comprehensive Plan Amendment Case No. CPA97-F-01[B] is an appeal by Gary Schmidt of the decision of the Planning Commission that denied a request to amend the Forest Area Plan, being a part of the Washoe County Comprehensive Plan.

The amendment requested re-designation of Assessor's Parcel Number 48-070-10 from the land use category of Medium Density Suburban (MDS: max 3 dwellings per acre) and General Rural (GR) to Tourist Commercial (TC) and to re-designate Assessor's Parcel Number 048-081-03 from Medium Density Suburban (MDS: max 3 dwellings per acre) to General Commercial (GC). The amendment request would allow a net increase in tourist/general commercial development potential of up to 6 acres. Assessor's Parcel Number 48-070-10 is located north of Mt. Rose Highway and is currently developed as the Tannenbaum Ski Area. Assessor's Parcel Number 048-081-03 is situated on the south side of Mt. Rose Highway immediately adjacent and south of the Reindeer Lodge.

The properties are approximately 2.5 miles southwest of Galena Forest Estates. The parcels are found within the Pleasant Valley Hydrographic Basin, in Section 17, T17N, R19E, MDM, Washoe County, Nevada.
