00-1005 PROCLAMATION – AMERICA'S SAFE SCHOOL WEEK – OCTOBER 15 – 21, 2000

Sherry Pheasant, the founder of Parent Patrol, and several Parent Patrol volunteers were present for adoption of the following proclamation, which Chairman Short read into the record. Ms. Pheasant advised they have over 400 parents who have dedicated over 75,000 hours to keep children safe in Washoe County. She said they know they are making a difference and thanked the Board members for their support.

Sam Dehne stated Parent Patrol is one of the best concepts he has seen come out of this area, which is now a nationwide program.

On motion by Commissioner Shaw, seconded by Commissioner Bond, which motion duly carried, it was ordered that the proclamation be adopted and Chairman Short be authorized to execute:

Using charts and graphs on the overhead screen, Marlene Rebori, Area Specialist, Cooperative Extension, presented the results of a telephone survey summarized in a draft report entitled: Community Profile - Citizen Advisory Boards (CAB), which was conducted by the University of Nevada to develop a profile of CAB members and to determine board members' interest in a training program. Ms. Rebori responded to Commissioners' questions and advised that every CAB member was called for the survey, but participation was voluntary.

00-1007 <u>FEDERAL GRANT PRIORITIES FOR GRANTWRITING</u> CONTRACT – GRANTS ADMINISTRATOR

Pursuant to questions at Caucus, Katy Singlaub, County Manager, reported that in the last fiscal year Washoe County received \$15.3-million in grant funding from federal sources. The County has one Grants Administrator, Sheila Leslie, and one full-time grant writer assigned to the District Attorney's office. There are many staff members who help their departments write grants, and Ms. Leslie has regular meetings with those people.

Commissioner Galloway reported he has been approached by organizations asking how they could get more grant funds, and noted the creation of an electronic tracking and notification system of grant opportunities, as indicated in the agenda memorandum, would provide such information. Ms. Singlaub advised that Ms. Leslie also distributes a newsletter electronically to all non-profit organizations seeking grants.

Upon recommendation of Ms. Leslie, on motion by Commissioner Sferrazza, seconded by Commissioner Bond, which motion duly carried, Chairman Short ordered that the federal grant proposal priorities, as outlined in the staff report placed on file with the Clerk, be accepted. It was further ordered that the Grants Administrator be authorized to direct the contractor, Randall Funding and Development [formerly Griffin Grant Writing and Consulting (GGW&C)], to prepare the appropriate grant proposals.

00-1008 <u>BILL NO. 1283 – AMENDING WCC CHAPTER 65 – 911</u> <u>SURCHARGE</u>

Bill No. 1283, entitled, "AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY EXTENDING THE SUNSET PROVISIONS FOR THE COLLECTION OF THE 911 SURCHARGE; MAKING THE EFFECTIVE DATE RETROACTIVE TO DECEMBER 31, 1999; AND PROVIDING OTHER MATTERS PROPERLY RELATING THERETO," was introduced by Commissioner Sferrazza, the title read to the Board and legal notice for final action of adoption directed.

On motion by Commissioner Bond, seconded by Commissioner Shaw, which motion duly carried, Chairman Short ordered that the Business Impact Statement concerning subject ordinance be acknowledged and approved.

00-1009 RESOLUTION - ACQUISITION OF SIERRA PACIFIC RESOURCES WATER BUSINESS – MANAGER

Katy Singlaub, County Manager, reported the City of Sparks unanimously approved submittal of a joint bid for the acquisition of Sierra Pacific's water business and

adopted the resolution, and the City of Reno will be considering the same actions at their meeting today.

Following discussion, upon recommendation of Katy Singlaub, County Manager, on motion by Commissioner Bond, seconded by Commissioner Galloway, which motion duly carried, Chairman Short ordered that the County Manager be delegated the authority to submit a non-binding indicative bid on behalf of the County as part of a joint bid with the Cities of Sparks and Reno for the acquisition of the water division of Sierra Pacific Resources. It was further ordered that the following resolution of support for the joint ownership and operation by the local governments of the water division of Sierra Pacific Resources be adopted and Chairman Short be authorized to execute:

RESOLUTION

WHEREAS, Sierra Pacific Resources (SPR) has decided to sell its Water Business; and

WHEREAS, SPR serves approximately 160,000 people in the Reno, Sparks and unincorporated Washoe County area; and

WHEREAS, SPR expects to receive "Non-Binding Indicative Bids" by October 20, 2000; and

WHEREAS, The Cities of Reno, Sparks and Washoe County have determined that control of the SPR Water Business, including approximately 166,000 acre feet of water rights, is essential to the well-being of the area; and

WHEREAS, The Cities of Reno, Sparks and Washoe County see many potential benefits to future conjunctive use of SPR resources with their own; and

WHEREAS, Loss of control of this valuable asset may have negative effects upon the Truckee River Operating Agreement (TROA); and

WHEREAS, The Cities of Reno, Sparks and Washoe County are submitting a joint "Non-Binding Indicative Bid" for the SPR Water Business by October 20, 2000; now, therefore, be it

RESOLVED, That the Board of Washoe County Commissioners does hereby express its support for a joint purchase and operation of the SPR Water Business.

00-1010 DEBT MANAGEMENT COMMISSION – BILL DRAFT REQUEST

As a Board member of the Debt Management Commission (DMC), Commissioner Galloway reported that at the last DMC meeting there was discussion about the Debt Management Commission getting a bill draft request allocation because of frustration expressed by DMC members about the statutes governing the DMC. He reported he

advised them it was too late to do anything for the upcoming session and suggested possible ideas for future consideration, such as requiring the DMC to submit proposed legislative changes far enough in advance for staff to incorporate them into Washoe County's BDR's.

Commissioner Shaw noted the DMC is a joint entities body and suggested the Cities of Reno and Sparks might be able to also do something. Katy Singlaub, County Manager, stated another possibility would be for the DMC to join in on the cooperative work done with such organizations as the Nevada Association of Counties, the League of Cities, etc.

Commissioner Galloway stated it has also been suggested to him that the SB253 committee might be able to help if the DMC wanted to do something this year. Ms. Singlaub stated there are also legislators the DMC could go to for assistance.

John Sherman, Finance Director, added there are other bodies, such as the Regional Planning Governing Board, who do not have BDR allocations either, and they usually work through NACO or the League of Cities.

Ms. Singlaub reported the remaining information concerning the results of the HayGroup study will be posted to the website by this afternoon.

Chairman Short suggested looking at the kennel permit procedures. Commissioner Bond stated the word "kennel" generates a mental image in people's minds. Ms. Singlaub stated staff will bring forth information for the Board's consideration.
