Katy Singlaub, County Manager, advised that Item 17 concerning the Amendment to Software License and Services Agreement for District Court shows an incorrect contingency transfer amount. Richard Schoot, Stead Neighborhood Advisory Board, provided a copy of an article from the Reno-Gazette Journal dated November 8, 2000 concerning an accidental firearm discharge by a Sheriff's reserve deputy at the Washoe County Shooting Range. 00-1110 ACKNOWLEDGEMENT – RECEIPT OF "ACHIEVEMENT OF EXCELLENCE IN PROCUREMENT" AWARD FOR THE YEAR 2000 – PURCHASING

John Balentine, Purchasing and Contracts Administrator, introduced staff members Darlene Penny and Charlene Collins. Mr. Balentine advised that each year the National Purchasing Institute increases the level of achievement for receipt of this award, and staff is proud to be the recipient five years in a row. Chairman Short presented the award and congratulated staff for their accomplishment.

Commissioner Galloway thanked the staff of the Purchasing Department for their efforts resulting in the receipt of this award.

It was noted this is the fifth such award in succession for the Purchasing Department.

Katy Singlaub, County Manager, advised that Washoe County is the only local government honored with the receipt of this award from the Environmental Protection Agency. She said John Fuller, Health Department, led the charge on recycling and John Balentine, Purchasing and Contracts Administrator, was very instrumental in purchasing recycled products.

Mr. Fuller advised he had the honor of going to Washington, D.C. to accept the award. He said Washoe County was in very elite company and named several of the corporations present at the ceremony. He advised there were 129 local governments across the U. S. represented in the competition. Mr. Balentine commented that the award is not the accomplishment of any one or two departments acting alone, and every County department helped receive this honor. Chairman Short presented the award and congratulated staff on their accomplishment.

Commissioner Galloway thanked all departments involved with the receipt of this award.

On motion by Commissioner Galloway, seconded by Commissioner Shaw, which motion duly carried, Chairman Short ordered that receipt of the prestigious award by the United States Environmental Protection Agency naming Washoe County as the "Waste Wise Partner of the Year for a Local Government" be acknowledged. It was noted that this is the second year in succession for the award.

00-1112 OPEN SPACE USE ASSESSMENT – 2000 TAX YEAR – INTERNATIONAL COMMUNITY OF CHRIST – NORTH END OF ANTELOPE VALLEY

9:30 a.m. This was the time set in a Notice of Public Hearing, published in the Reno Gazette-Journal on November 10, 2000 to consider the application for Open Space Use Assessment (2000 tax year) by the International Community of Christ for the following 14 parcels totaling approximately 683 acres of land located on the north end of Antelope Valley:

These parcels were not designated as desirable open space as they have a residential land use of Low Density Rural in an area of the North Valleys where private land is not plentiful.

Chairman Short opened the public hearing.

Ronald Shane, Appraiser, Assessor's Office, reviewed background information concerning the applications for Open Space Assessment submitted by the International Community of Christ. He advised that the open space land use assessment contains two components, being (1) what is desirable open space, and (2) what are the tax consequences. He said the Assessor's office addressed the tax consequences issue but no solid definition of open space is available and they relied heavily on the Department of Community Development to identify what would be considered desirable open space. He advised that the Department of Community Development used the Washoe County Regional Open Space Plan and the Washoe County Development Code for their analysis of the applications. Mr. Shane then stated that the applicant just advised they are withdrawing the application for the 14 parcels on the north end of the property.

Chairman Short asked if anyone wished to speak on this item. There was no response and the public hearing was closed.

On motion by Commissioner Galloway, seconded by Commissioner Bond, which motion duly carried, Chairman Short ordered that the withdrawal by the International Community of Christ of the application for Open Space Use Assessment (2000 tax year) for 14 parcels of land located on the north end of Antelope Valley be accepted.

00-1113 <u>OPEN SPACE USE ASSESSMENT – 2000 TAX YEAR –</u> <u>INTERNATIONAL COMMUNITY OF CHRIST – SOUTH END</u> <u>OF ANTELOPE VALLEY</u>

<u>9:30 a.m.</u> This was the time set in a Notice of Public Hearing, published in the Reno Gazette-Journal on November 10, 2000 to consider the application for Open Space Use Assessment (2000 tax year) by the International Community of Christ for the following 11 parcels totaling approximately 659 acres of land located on the south end of Antelope Valley:

079-440-08 [43.55 acres]; 079-440-09 [58.95 acres]; 079-440-10 [47.19 acres]; 079-440-12 [80.24 acres]; 079-440-13 [79.57 acres]; 079-440-14 [62.54 acres]; 079-440-15 [40.73 acres]; 079-440-28 [50.73 acres]; 079-440-29 [40.85 acres]; 079-540-01 [80.40 acres]; 079-540-08 [73.23 acres]

These parcels, or portions of them, are designated as desirable open space for a single reason, which is their hilly areas being a visual resource to the local community.

Chairman Short opened the public hearing.

Ronald Shane, Appraiser, Assessor's Office, referred to maps provided with the agenda material and reviewed the areas located on the south end of Antelope Valley that have been designated as desirable open space. He advised that religious structures and areas around those structures are exempt from taxation, and after subtracting the exempt areas, approximately 175 acres are eligible for open space designation. He said the tax consequence at current market value is approximately \$400 annually. Upon inquiry of Commissioner Bond, Mr. Shane advised that requiring public access to a designated open space area is a consideration the Board would make; and that the perimeter of these parcels is fenced and gated and does not provide easy access to the public.

Upon inquiry of Commissioner Bond, Legal Counsel Shipman advised that the County Code and State law gives the Board authority to condition approval of an open space designation with a requirement of public access, but there is no mandate that public access be available.

Reverend Gene Savoy, International Church of Christ, advised that the application was made as part of their long-term plan to maintain large areas of the property in its natural state. He advised they are working with the Natural Resources Conservation Service of the U.S. Department of Agriculture (USDA) and the Nevada Division of Forestry (NDF) to enhance and preserve areas for native wildlife. He provided a map depicting those areas. He noted that the land they are working on with the USDA and NDF is not contained on the Assessor's map and requested those lands also be designated as open space. Upon inquiry of Commissioner Bond, Reverend Savoy advised that access is currently limited to religious services but beginning in the spring, the sanctuary would be open for the spring, summer and fall periods on a regular schedule. He then provided a video presentation of the subject project showing exempt portions of the property and open space areas.

Legal Counsel Shipman noted that the request before the Board is not for a land use designation but simply for a tax designation.

Chairman Short requested that persons wishing to speak address the Board at this time.

Mac Coakwell, County resident, spoke in opposition to the open space application. He said the application was made to avoid taxes and other assessments against the property. He advised that the Red Rock Estates Property Owners Association assesses all properties for the maintenance of roads within the Association boundaries and if this application is approved, the church would then have reason to request a different treatment than the other residential properties in the Association. Upon inquiry of Commissioner Galloway, Legal Counsel Shipman advised that approval of the application would not affect any assessments imposed by the Red Rock Homeowner's Association.

Jeannie Fow, County resident, advised that she is a member of the North Valleys Citizen Advisory Board, the Red Rock Property Owner's Association, and a homeowner and property owner in the subject area. She showed a map of the area portraying the parcels in question and showing the slope areas and areas most suitable for development according to the North Valleys Area Plan. She said every property owner in the area has similar property and pays the standard Washoe County tax, and, while she understands the request is only for tax purposes, she questions whether this would create the potential for land use changes in the future. Ms. Fow commented that she does not think it would be fair to grant open space to one property owner without allowing the same designation for everyone that owns the same type of property.

Chairman Short read comments presented by Elizabeth McKee stating her opposition to the open space designation request based on concerns regarding possible affects on property assessments for paving projects.

There being no one else wishing to speak, Chairman Short closed the public hearing.

Commissioner Galloway commented that he does not believe there is a threat to the assessment on the properties, but thinks approval would open the door for a series of these types of requests. He said he is leaning toward being rather rigid and not going any further than what can clearly be seen as desirable open space.

Commissioner Bond asked if the church would be agreeable to a condition requiring public access. Reverend Savoy advised that he believes such a condition would be acceptable.

Commissioner Sferrazza stated that he is concerned about the hundreds of parcels in the County that are not developed and the property owner could make the same request. Upon Commissioner Sferrazza's inquiry, Legal Counsel Shipman advised that State law provides that any owner of property may make an open space designation application, and every case that comes before the Board would need to be reviewed on their facts. She advised that the Board has discretion either allow or not allow this exemption for tax purposes. Ms. Shipman then commented that the Board has the option to look at the criteria issue concerning open space designations, and this could be placed on a future agenda for discussion.

Mike Harper, Planning Manager, Department of Community Development, provided additional information and responded to questions of the Board. He noted that the map presented by Ms. Fow represents an analysis of slopes and other types of properties and does not address the open space plan, and many of those parcels would not be considered eligible for open space. He noted there are no criteria to deal with this type of issue because it is not seen very often and suggested that the Board consider scheduling a discussion concerning the open space plan.

Commissioner Bond stated the church has made a great gesture with what they want to do with the property, but she is concerned about the criteria issue.

Commissioner Galloway commented that he is concerned about approving the application without thinking through all of the associated consequences. He said he believes that well thought out criterion needs to be established before approving these kinds of applications.

Reverend Savoy commented that, when they initially started the process they considered it a good community thing to do, and their entire motive was to preserve the wildlife in the area. He said they have since recognized that this is a gray area, and there are many questions. They understand the problems the Commission may have in deciding this issue and would feel comfortable with any decision the Commission makes.

Commissioner Shaw moved, in light of the statement made by Reverend Savoy that they would be comfortable with whatever decision the Board makes and his concerns about public access and opening the door for similar requests by property owners, that the application for Open Space Use Assessment (2000 tax year) by the International Community of Christ for 11 parcels on the south end of Antelope Valley be denied. He further moved that the Ordinance concerning this issue be presented to the Board at a future date for consideration of greater criteria regarding open space designations. Commissioner Galloway seconded the motion. On call for the question, the motion passed unanimously.

Bill No. 1285 entitled, "AN ORDINANCE AMENDING THE WASHOE COUNTY CODE BY AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS TO SET THE AMOUNT OF THE 911 SURCHARGE BY RESOLUTION IN ORDER TO ADJUST THE AMOUNT OF THE UNENCUMBERED BALANCE IN THE SURCHARGE REVENUE FUND AT FISCAL YEAR END, AND CHANGING THE TIME FOR REMITTANCE OF THE SURCHARGE TO MONTHLY TO CONFORM WITH STATE LAW," was introduced by Commissioner Bond, the title read to the Board, and legal notice for final action of adoption directed.

00-1115 <u>BILL NO. 1286 – AMENDING WCC CHAPTER 110 –</u> <u>DEVELOPMENT CODE – HYDROLOGIC RESOURCES</u>

Bill No. 1286 entitled, "AN ORDINANCE AMENDING PROVISIONS RELATING TO WASHOE COUNTY CODE CHAPTER 110, BY SUBSTITUTING ARTICLE 418, SIGNIFICANT HYDROLOGIC RESOURCES FOR ARTICLE 418, WETLANDS (A RESERVED ARTICLE), TO INCORPORATE NEW STANDARDS

TO REGULATE DEVELOPMENT AREAS ADJACENT TO PERENNIAL STREAMS IN THE UNINCORPORATED AREAS OF WASHOE COUNTY. THIS ARTICLE ESTABLISHES STANDARDS FOR USE OF LAND IN "CRITICAL STREAM ZONE BUFFER AREA" AND "SENSITIVE STREAM ZONE BUFFER AREA" TO PRESERVING AND PROTECTING PERENNIAL STREAMS WITHIN WASHOE COUNTY TO IMPLEMENT A POLICY OF "NO NET LOSS" OF SIGNIFICANT HYDROLOGICAL RESOURCE SIZE, FUNCTION AND VALUE. THE PROPOSED STANDARDS RELY ON THE SPECIAL USE PERMIT PROCESS TO IDENTIFY APPROPRIATE MITIGATION WHEN DEVELOPMENT COMES WITHIN 150 FEET OF THE CENTERLINE OF IDENTIFIED PERENNIAL STREAMS. CHANGES ARE ALSO PROPOSED FOR ARTICLE 902, DEFINITIONS, TO ADD NEW DEFINITIONS AS APPROPRIATE TO CLARIFY PHRASES AND TERMS IN ARTICLE 418, SIGNIFICANT HYDROLOGIC RESOURCES, AND OTHER MATTERS PROPERLY RELATING THERETO," was introduced by Commissioner Sferrazza, the title read to the Board, and legal notice for final action of adoption directed.

Mike Harper, Planning Manager, Department of Community Development, presented material containing grammatical changes, definitions approved in a previous ordinance, the addition of comments received from the Citizens Advisory Board, etc. He advised there have been no changes to the intent of the ordinance and the ordinance does not affect the Truckee River, ditches, Tahoe Area Plan, or the high desert area.

Commissioner Galloway commented that he would like something contained in the ordinance to indicate that a ditch is not considered a perennial stream and clearly indicates that it is not the intent of the ordinance to put a restriction on property just because it borders a ditch.

Mr. Harper advised that approximately 2500 notices were sent out regarding this matter, and there seems to be a great deal of support for the ordinance amendment.

On motion by Commissioner Bond, seconded by Commissioner Galloway, which motion duly carried, Vice Chairman Shaw ordered that Michael Harper, AICP, Planning Manager, Department of Community Development, be reappointed as first alternate and Robert W. Sellman, Community Development Director, be appointed as second alternate for the Board of County Commissioners representative to the Tahoe Regional Planning Agency Governing Board.

00-1118 ANDERSON PARK PHASE I DESIGN – PARKS

Upon recommendation of Karen Mullen, Director, Department of Parks and Recreation, on motion by Commissioner Sferrazza, seconded by Commissioner Bond, which motion duly carried, Vice Chairman Shaw ordered that the Anderson Park Phase I Design be approved.

It was noted that this phase of park development is located at the end of Yoakum Lane on the southeast corner of the property. It will provide access and park facilities for residents living south of Huffaker Lane and in the Country Estates and Crystal Lakes developments. The development will include individual and group picnic areas, parking, trail connections open turf area and trees.

Katy Singlaub, County Manager, noted that staff indicated at yesterday's caucus meeting that it is not expected the total amount of this contract will be required from Contingency. She advised there was agreement between Information Technology (IT), Finance, and District Court, that the work plan and service agreement with the IT Department would be completed before funds are expended.

Ms. Gibbons advised that part of the contract is for Maximus to teach staff how to increase revenues by maximizing claims to federal programs and to identify other revenue sources.

Upon recommendation of Mike Capello, Director, Department of Social Services, on motion by Commissioner Bond, seconded by Commissioner Galloway, which motion duly carried, it was ordered that the Agreement between Washoe County and Maximus, Inc., concerning revenue maximization consultation and assistance effective November 1, 2000 through December 31, 2001 in the approximate amount of \$177,400 for Fiscal Year 2000/01 with an additional \$10,000 due in Fiscal Year 2001/02 be approved, and Chairman Short be authorized to execute.

Commissioner Bond said the County is failing in certain dust matter issues and it is time to look at what is going to be done about some of the private dirt roads, many of which are in suburban type communities. Commissioner Shaw noted that he was unable to attend yesterday's caucus meeting and requested an update regarding the Vector Management workshop.

Commissioner Sferrazza requested that an item be placed on the agenda concerning the creation of a task force with regard to the Courts, District Attorney office space, etc. Ms. Singlaub advised that a meeting is scheduled for November 28, 2000 of the users of the justice facilities and City of Reno staff, and staff will bring this issue to the Board on December 12, 2000 for direction.
