The Board met in regular session in the Commission Chambers of the Washoe County Administration Complex, 1001 East Ninth Street, Reno, Nevada. Following the Pledge of Allegiance to the flag of our Country, the Clerk called the roll and the Board conducted the following business:

03-1024 <u>AGENDA</u>

In accordance with the Open Meeting Law, on motion by Commissioner Shaw, seconded by Commissioner Weber, which motion duly carried with Commissioner Sferrazza temporarily absent, Chairman Humke ordered that the agenda for the September 16, 2003 meeting be approved.

PUBLIC COMMENTS

Paul Woods, Spanish Springs resident, requested the Board terminate the North Spanish Springs stormwater fee because the County is not providing services and does not plan to provide services to the area where he lives.

***1:10 p.m.** Commissioner Sferrazza arrived at the meeting.

Eddie Anderson, Reno resident, read a story about a grasshopper and an ant, and asked that people vote Republican.

Sam Dehne, Reno resident, discussed two lawsuits he filed, and he sang about heroes.

Al Hesson, local resident, talked about September 11, President Bush, terrorists, sending money to Iraq and starving senior citizens.

MANAGER'S/COMMISSIONERS' COMMENTS

Commissioner Galloway requested a five-minute workshop at caucus concerning wasteful monthly billings of less than \$20.

Commissioner Shaw said he would be happy to speak with Mr. Woods and address his issues.

Commissioner Weber thanked all who attended the Sun Valley Citizen Advisory Board meeting concerning a task force to address safety and pedestrian issues in Sun Valley, including County employees and elected County officials and State Legislators.

Commissioner Sferrazza requested information concerning the requirement for curbs, gutters and sidewalks in new developments of one-third acre or less in the County. He also asked that the County request the Regional Transportation Commission to prepare a pedestrian and bicycle plan for the County.

03-1025 <u>PROCLAMATION – GOOD NEIGHBOR DAY</u>

Commissioner Shaw read the Proclamation declaring September 17 as Good Neighbor Day and presented the Proclamation to Tony Fiannaca of Sparks Florist. Mr. Fiannaca thanked the Board for supporting Good Neighbor Day and said it only works with the support of the community.

On motion by Commissioner Sferrazza, seconded by Commissioner Galloway, which motion duly carried, Chairman Humke ordered that the following Proclamation be adopted:

03-1027 <u>SEXUAL ASSAULT – MEDICAL CARE – PAYMENT</u>

Pursuant to NRS 217.280 to 217.350, on motion by Commissioner Shaw, seconded by Commissioner Sferrazza, which motion duly carried, Chairman Humke ordered that payments with funds from the District Attorney's account designated Sexual Assault Victims Expenses be authorized for initial emergency medical care and follow-up medical or psychological treatment for 34 sexual assault victims in an amount totaling \$3,038.89 as set forth in a memorandum from Lidia Osmetti, Office Manager, District Attorney's Office, dated August 28, 2003 and placed on file with the County Clerk.

03-1028 <u>SOLE SOURCE PURCHASE – TORO MOWER – PARKS</u>

County Manager Katy Singlaub reviewed the Toro Grounds Master 4000-D Mower specifications and advised the Board that the Jacobsen and John Deere turf mower engines are not as powerful as the Toro, and a more powerful engine is desirable at high altitudes. She stated the Toro also has the maximum operator view.

Upon recommendation of John Balentine, Purchasing and Contracts Administrator, on motion by Commissioner Shaw, seconded by Commissioner Sferrazza, which motion duly carried with Commissioner Sferrazza voting "no," Chairman Humke ordered that the purchase of one new Toro Grounds Master 4000-D Mower, on behalf of the Parks and Recreation Department, from Turf Star Inc., as a sole source provider, in the amount of \$40,261.40, be approved. It was noted Commissioner Sferrazza said he felt the mower should be put out to bid.

This was the time to consider award of the bid for parking and shelter improvements at the Sun Valley Community Park for the Public Works Department. The Notice to Bidders for receipt of sealed bids was published on August 22 and 27, 2003.

He said denying grant money would mean not returning to local taxpayers the money they send to Washington.

Following discussions, Commissioner Shaw moved to grant the partial refund of taxes for DP Operating Partnership L.P., as recommended by Blaine Cartlidge, Deputy District Attorney, in D.A. Opinion No. 6414. Commissioner Galloway seconded the motion. The motion failed with Commissioner Sferrazza voting "no." It was noted Commissioner Sferrazza said he is not in favor of the Board handling tax refunds and he thinks the system is unfair.

Sam Dehne, local resident, questioned where the kiosks would be located, what they would look like and if they would be manned.

Upon recommendation of Marietta Bobba, Senior Services Director, on motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried, Chairman Humke ordered that an unbudgeted capital outlay request up to \$86,300 for the purchase of eight informational kiosks and miscellaneous building improvements (wiring, routing and phone line upgrades) for the Senior Services Department from within the Single Point of Entry grant be approved and the Comptroller be directed to make the following account changes on the condition the proposed list of kiosk locations comes back to the Board for approval.

03-1043 <u>INITIATE COMPREHENSIVE PLAN AMENDMENT – BRIEN</u> WALTERS' PROPERTY – PARKS

Gary Schmidt, Washoe County resident, said he is familiar with the area in question, it is a historical area, and he feels it should be a high priority for the County to acquire.

Upon recommendation of Mike Boster, Planner, through Karen Mullen, Parks and Recreation Director, on motion by Commissioner Sferrazza, seconded by Commissioner Shaw, which motion duly carried, Chairman Humke ordered that the Parks Department be directed to initiate a Comprehensive Plan Amendment for the 26.92-acre Brien Walters' property (APN No. 046-060-01) to change the land use designation from General Rural (1-dwelling unit per 40-acres) to Medium Density Rural (1-dwelling unit per 5-acres) on 20.75-acres and from General Rural to Parks & Recreation on the remaining 6.17-acres. It was further ordered that the application fee of \$4,918 be waived for the Comprehensive Plan Amendment.

03-1044 <u>DISCUSSION – WILDCREEK GOLF COURSE – RSCVA – PARKS</u>

Karen Mullen, Parks and Recreation Director, reviewed the ownership of Northgate and Wildcreek golf courses.

Commissioner Shaw disclosed a phone conversation he had with John Sande, attorney for the Reno-Sparks Convention and Visitors Authority (RSCVA), and Mr. Sande said if the County is interested, he would like to discuss the issues with County staff.

Joe Kelley, General Manager of Golf, RSCVA, stated capital improvements were funded out of a capital improvement account and not charged directly to the golf courses.

John Rhodes, Deputy District Attorney, reviewed Nevada Revised Statute 244A.627 and answered questions of the Board.

On motion by Commissioner Galloway, seconded by Commissioner Sferrazza, which motion duly carried, Chairman Humke ordered that the policy positions related to the possible sale of Wildcreek and Northgate golf courses as set forth in the memorandum from Michelle Poché dated September 16, 2003, and placed on file with the County Clerk, be approved with the following amendments: the first bullet point would add to the end of the sentence "or of any intent to cease golf operations on either course"; the fourth bullet point would include language concerning deed restrictions; and the sixth bullet point would read "Washoe County remains interested in exploring with the owners of the other four publicly owned golf courses in the Truckee Meadows region, and other concerned parties who may be helpful, the feasibility of alternative management options." It was further ordered that staff be directed to explore with the RSCVA and other concerned parties the options for preserving public use and open space on both properties in the event that golf use is discontinued.

On motion by Commissioner Sferrazza, seconded by Commissioner Shaw, which motion duly carried, Chairman Humke ordered that staff be directed to explore, through negotiations with the RSCVA, possible acquisition of Wildcreek and/or Northgate golf courses, through either direct ownership or alternative management options.

03-1045 <u>AUTHORIZE TREASURER TO AUCTION TAX DELINQUENT</u> LANDS – PUBLIC WORKS

Upon recommendation of David Price, County Engineer, through Tom Gadd, Public Works Director, on motion by Commissioner Sferrazza, seconded by

Commissioner Shaw, which motion duly carried, it was ordered that the Washoe County Treasurer be authorized to auction all tax delinquent lands held in trust, with the exception of those parcels listed on Exhibit "A". It was further ordered that the following Resolution be adopted and Chairman Humke be authorized to execute the same. It was noted the 2003 Tax Delinquent Lands Book is on file in the County Manager's office.

RESOLUTION

A RESOLUTION DIRECTING THE COUNTY TREASURER TO TRANSFER TO OTHER GOVERNMENTS REAL PROPERTY HELD IN TRUST BECAUSE OF PROPERTY TAX DELINQUENCIES AND OTHER MATTERS PROPERLY RELATED THERETO.

WHEREAS, after the expiration of the period of redemption for tax delinquent parcels of real property the county tax receiver is required to execute and deliver deeds conveying title to such property to the county treasurer in trust for the use and benefit of the state and county, (NRS 361.585);

WHEREAS, upon the order of the board of county commissioners entered upon the record of its proceedings, such tax delinquent parcels held in trust by the treasurer may be conveyed in the manner required by state law after proper notice is given, (NRS 361.595);

WHEREAS, attached to this resolution and incorporated herein is Exhibit A, a list of tax delinquent parcels held by the county treasurer in trust that the board of county commissioners desires to have conveyed to other governments as more specifically set forth in Exhibit A;

WHEREAS, pursuant to NRS 361.603 local governments or the University System are authorized to acquire property held in trust by the county to serve a public purpose in return for the payment of the delinquent taxes; and

WHEREAS, pursuant to NRS 361.603 no delinquent taxes need be paid for property transferred to a local government for street, sewer or drainage uses, for use in a program for the rehabilitation of abandoned residential properties established by the local government pursuant to chapter 279B of NRS, or for use as open-space real property as designated in a city, county or regional comprehensive,

NOW THEREFORE BE IT HEREBY RESOLVED by the Washoe County Board of County Commissioners as follows:

1. The Washoe County Board of County Commissioners finds that transferring the parcels listed in Exhibit A to Washoe County would serve the public purposes stated in the exhibit.

2. The Washoe County Treasurer is hereby ordered pursuant to NRS 361.603 to transfer the parcels listed in Exhibit "A" to Washoe County for the purposes stated in Exhibit "A" in the manner required by state law after proper legal notice has been given. The payment of delinquent taxes is not required because the property is to be used for purposes which qualify for the exemption from payment as stated above.

3. If some irregularity or circumstance arises before the transfer of any certain parcel listed in the exhibits to this resolution such that in the opinion of the Washoe County Treasurer the public interest would best be served by withdrawing such a parcel from a sale or transfer, the Washoe County Treasurer is hereby expressly authorized to make such a withdrawal on behalf of the county. The treasurer shall report to the board in writing his or her decision to make such a withdrawal and shall state the reasons for the decision. The board may thereafter permit the parcel to remain in trust for the benefit of the state and county or may again order it be sold or transferred.

EXHIBIT "A"

Wallace Stephens, attorney for Castles, LLC, explained this parcel is in litigation based on an appeal filed. He spoke concerning the fact the Resolution does not say proper legal notice must be given to the delinquent taxpayer and he does not feel that notice was given.

RESOLUTION

A RESOLUTION DIRECTING THE COUNTY TREASURER TO TRANSFER REAL PROPERTY HELD IN TRUST BECAUSE OF PROPERTY TAX DELINQUENCIES AND OTHER MATTERS PROPERLY RELATED THERETO. WHEREAS, after the expiration of a period of redemption for tax delinquent parcels of real property the county tax receiver is required to execute and deliver deeds conveying title to such property to the county treasurer in trust for the use and benefit of the state and county, (NRS 361.585);

WHEREAS, upon the order of the board of county commissioners entered upon the record of its proceedings, such tax delinquent parcels held in trust by the treasurer may be conveyed in the manner required by state law after proper notice is given and final redemption or reconveyance rights are waived, (NRS 361.585 and 361.595);

WHEREAS, a parcel of real property located in Washoe County near the intersection of the Pyramid Highway and Eagle Canyon Drive presently known as Assessor's Parcel Number 089-460-25 (the "Subject Parcel") was previously included on a list of tax delinquent parcels held by the county treasurer in trust ordered by the board of county commissioners to be auctioned by the treasurer (November 13, 2001);

WHEREAS, information provided to the board subsequent to the November 13, 2001 order by the public works department shows the Subject Parcel is: irregularly shaped; burdened with numerous drainage easements traversing much of the parcel from various directions; further burdened with a drainage detention/retention facility; and has no current legal access to any street;

WHEREAS, the drainage facilities on the Subject Parcel serve an adjacent, large residential subdivision and no alternative drainage system is presently available;

WHEREAS, prior to the scheduled April 10, 2002 auction, the treasurer pulled the Subject Parcel from the auction at the request of public works after the burdens on the property were demonstrated to the treasurer;

WHEREAS, the treasurer's legal authority to withdraw the parcel from the auction was confirmed by the Washoe County District Court (Case No. CV02-02474);

WHEREAS, pursuant to NRS 361.603 Washoe County is authorized to acquire property held in trust if the property would serve a public purpose and the delinquent taxes need not be paid if the property transferred to a local government is to be used for street, sewer or drainage uses, for use in a program for the rehabilitation of abandoned residential properties established by the local government pursuant to chapter 279B of NRS, or for use as open-space real property as designated in a city, county or regional comprehensive plan,

NOW THEREFORE BE IT HEREBY RESOLVED by the Washoe County Board of County Commissioners as follows:

1. The Subject Parcel's original and continuing primary use and purpose was a public drainage utility and is presently unbuildable due to the drainage burdens and lack of access.

2. The Subject Parcel serves an important public need and should be placed into the County's ownership.

3. The Washoe County Treasurer IS HEREBY ORDERED pursuant to NRS 361.603 to transfer the Subject Parcel to Washoe County for the purposes stated in this resolution.

4. The payment of delinquent taxes is not required of Washoe County because the property to be transferred is to be used for purposes that qualify for the exemption from payment as stated above.
