The Board met in regular session in the Commission Chambers of the Washoe County Administration Complex, 1001 East Ninth Street, Reno, Nevada. Following the Pledge of Allegiance to the flag of our Country, the Clerk called the roll and the Board conducted the following business:

#### 03-1200 WORK CARD PERMIT APPEAL – GEORGE J. MARI

The appeal by George J. Mari of the Sheriff's denial of his work card permit application was considered on Monday, November 10, 2003 prior to the Caucus meeting.

On motion by Commissioner Shaw, seconded by Commissioner Sferrazza, which motion duly carried with Commissioner Weber temporarily absent, the Board convened in closed session to hear testimony as to why the work card should or should not be granted.

The appellant George Mari was present to offer testimony during the closed session.

Also present was Maureene Thomas, Chief Records Clerk, Washoe County Sheriff's Office.

On motion by Commissioner Shaw, seconded by Commissioner Sferrazza, which motion duly carried, the Board reconvened in open session and the following action was taken:

On motion by Commissioner Sferrazza, seconded by Commissioner Weber, which motion duly carried with Commissioner Galloway voting "no," it was

ordered that the appeal be upheld and the work card permit be issued to George Joseph Mari on the condition the applicant not get arrested.

# 03-1201 <u>AGENDA</u>

In accordance with the Open Meeting Law, on motion by Commissioner Galloway, seconded by Commissioner Weber, which motion duly carried with Commissioner Sferrazza absent, Vice Chairman Shaw ordered that the agenda for the November 12, 2003 meeting be approved with the following changes: <u>Delete</u> Item No. 7E2, a Resolution Adopting the Amended Tahoe Area Plan, and <u>Correct</u> Item No. 7J3 by changing the Washoe County Health District to the Washoe County District Health Department.

Chairman Humke assumed the gavel.

# PUBLIC COMMENTS

Wanda Wright, President of the Warm Springs Property Owners' Association, and Shari Albin, Tony Novelly, John Copp, John Glatthar, Laura Sheline, Jack Albin and Katherine Snedigar spoke against a proposed teen ranch in the Palomino Valley/Warm Springs area. They sited concerns such as the safety of senior citizens and children, personal property at risk, potential nighttime light pollution, poor roads, emergency access and response times, water quality, type of sewage that would be required, rural lifestyle and a violation of the Warm Springs Area Plan. Chairman Humke read into the record comments from Mary Kingland, Lani Albin, Catherine Glatthar and Julie Brandt also against the proposed teen ranch in their area.

Al Hesson, local resident, said only two members of Congress have sons in the military, neither of which is currently serving in Iraq.

Sam Dehne, Reno resident, sang a song and played his guitar for veterans. He thanked the Commission for allowing three minutes per person for public comments.

Gary Schmidt, Washoe County resident, stated he does not think Burning Man has been properly acknowledged for its benefit to the community. He also discussed electronic voting machines and said votes cannot be secure in electronic equipment and he recommended maintaining a hard copy backup.

# MANAGER'S/COMMISSIONERS' COMMENTS

Katy Singlaub, County Manager, said the proposed teen ranch is not a Washoe County project, and she would ensure the comments expressed would be forwarded to the Department of Community Development. Commissioner Shaw said he is aware of what is going on regarding the teen ranch and the residents' concerns.

Chairman Humke acknowledged veterans and an event held at the Veteran's Guest House on Veteran's Day.

Commissioner Galloway requested the Fire District share lessons learned from the southern California fires with the Board on November 18, 2003. He also requested an item on the next agenda concerning voting equipment and voting practices in order to comply with Federal, State and County regulations. He stated he would be sending a letter to the Secretary of State, as a single County Commissioner, requesting that, when the Secretary evaluates the voting equipment, availability for a paper ballot recount potential be mandatory.

Commissioner Shaw said he was honored to represent Washoe County at the Veteran's Day Parade.

Commissioner Weber stated she attended an adoption fair at Hidden Valley Elementary School, which was a good event.

Chairman Humke informed the Board that he met with the Mayors of Reno and Sparks, and they all approved, in concept, rules to govern quarterly joint entity meetings; and those rules would be brought to the Board for approval. He said Mayor Cashell noted the Veteran's Day Parade was a Reno event, and he apologized for not informing and inviting the City of Sparks and Washoe County. He stated he committed to the Mayors that the County would extend invitations to upcoming events that may impact the two Cities.

On motion by Commissioner Galloway, seconded by Commissioner Weber, which motion duly carried with Commissioner Sferrazza absent, Chairman Humke ordered that this item be continued to November 25, 2003.

#### 03-1203 <u>UPDATE – REGIONAL PLAN SETTLEMENTS AND</u> <u>ASSOCIATED ISSUES</u>

Madelyn Shipman, Assistant District Attorney, reported she received a proposed scheduling Order and she advised Mr. Azevedo that Washoe County could abide by the dates. She said the briefing on the mediations, with suggestions for possible resolution, must be in by November 26, 2003, and she would bring proposals to the Board for approval or changes on November 25, 2003. Briefs concerning the Petition for Clarification are due December 4, 2003, and the hearing to commence the Court's review of all of these items is set for December 19, 2003.

Adrian Freund, Community Development Director, stated the first step in the appeal of the Reno Program of Annexation would be at the Regional Planning Commission meeting. He said the Judge directed that a protocol be developed for handling cooperative planning applications to ensure they are complete, address all criteria and development standards for cooperative planning, and establish a set of rules for deeming when those applications are incomplete.

Sam Dehne, Reno resident, said the worst aspect of annexation is rezoning, and it is an insult to the Regional Plan.

Nancy Parent, Chief Deputy Clerk, read the Proclamation declaring November 17-21, 2003 as *CAN*struction Week in Northern Nevada into the record and Chairman Humke presented the Proclamation to Ken Bartlett, President, American Institute of Architects for Northern Nevada (AIANN), and Doris Phelps of the Food Bank of Northern Nevada.

**WHEREAS**, The firms in the design industry, including architects, engineers and contractors, will engage in friendly public competition to obtain this food by constructing projects using only canned and packaged foods; and

**WHEREAS**, Following the competition, the food will be given to the Food Bank of Northern Nevada of Washoe County for distribution to the hungry in the State of Nevada; now, therefore, be it

**PROCLAIMED**, That the Washoe County Board of Commissioners do hereby proclaim the week of November 17<sup>th</sup> through the 21<sup>st</sup>, 2003, as *CAN*struction Week in Northern Nevada.

Upon recommendation of Marietta Bobba, Senior Services Director, on motion by Commissioner Galloway, seconded by Commissioner Shaw, which motion duly carried with Commissioner Sferrazza absent, it was ordered that the following Proclamation be adopted and Chairman Humke be authorized to execute the same:

## PROCLAMATION

WHEREAS, Family caregivers provide more than 80% of all homecare services; and

**WHEREAS**, Collectively it is believed that these individuals contribute some \$257 billion annually to the nation's health care system by providing services and products, significantly reducing costs to Medicare, Medicaid and private payers; and

WHEREAS, Caregivers are making a huge contribution; and

WHEREAS, Two-thirds of all caregivers are employed, both full-time or part-time; and

**WHEREAS,** Caregivers often experience substantial stress and burdens as a consequence of care giving duties; and

WHEREAS, Prolonged care giving can adversely affect one's physical and psychological health, which can affect current and future earning capability and potentially affect the ability to balance the needs of older parents with younger families, as well as meeting personal needs; and

**WHEREAS**, There is always a need for information about available community services for caregivers and for those who need care; now, therefore, be it

**PROCLAIMED,** That the Washoe County Board of Commissioners does hereby proclaim November 2003 as NATIONAL FAMILY CAREGIVERS MONTH and the Board urges all Washoe County citizens to join community efforts in recognizing and helping those who care for others. Ms. Bobba introduced Diane Ross, Chairperson, Northern Nevada Caregivers Coalition. Ms. Ross said this is a wonderful gesture on behalf of the County because caregivers need to be recognized and honored. She introduced Jeannie and Paul Smith, caregivers. Mr. Smith stated they could not do what they are doing without the Continuum. Ms. Bobba noted the Senior Center would be celebrating caregivers on November 25<sup>th</sup> at 1:00 p.m.

Sam Dehne, local resident, said this is near and dear to his heart and he is proud of caregivers.

### 03-1217 <u>RESIGNATION/APPOINTMENT – WARM SPRINGS CITIZEN</u> <u>ADVISORY BOARD</u>

On motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried with Commissioner Sferrazza absent, Chairman Humke ordered that the resignation of Jeanne Dembenski as an at-large representative on the Warm Springs Citizen Advisory Board (CAB) be accepted and Laurie J. York be appointed to fill the vacancy with the term to expire June 30, 2005.

# 03-1218 REQUEST FOR PROPOSALS – PRELIMINARY AND FINAL DESIGN SERVICES – WATER TREATMENT FACILITY – HIDDEN VALLEY WATER SYSTEM

Steve Bradhurst, Water Resources Director, reviewed the staff report dated October 20, 2003, which was placed on file with the County Clerk. He advised that the County's site on Longley Lane is a possible location for the water treatment facility for the Hidden Valley Water System. It is expected that wholesale water rates would be increasing, which the County has no control over; and a treatment facility would provide flexibility. In response to Commissioner Shaw, Mr. Bradhurst said he is not aware of any Federal assistance available, but he would check. He stated there would be additional connections and a connection fee would be imposed to help pay for the cost of the facility. A portion of the arsenic surcharge, which is currently being charged, could also be applied to help pay for the facility. He further said the treatment techniques have not yet been established.

Mr. Bradhurst responded to several questions from Board members concerning the use of Truckee River water rights, Truckee Meadows Water Authority (TMWA), Hidden Valley Well Number Four, and the perchloroethylene (PCE) fee that everyone receiving water from TMWA must pay. He also confirmed the connection would be to the County system and not to the South Truckee Meadows General Improvement District (STMGID) system.

Upon recommendation of Paul Orphan, Engineering Manager, through Steve Bradhurst, Water Resources Director, on motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried with Commissioner Sferrazza absent, Chairman Humke ordered that the Department of Water Resources staff be authorized to request proposals from engineering consultants for preliminary and final design services for a water treatment facility proposed for the Hidden Valley Water System. It was further ordered that the Engineering Manager be directed to initiate the consultant selection process, determine a draft scope of work and negotiate a fee schedule with the chosen consultant team.

It was noted the scope of work and the consultant fee schedule would be brought back to the Board for final approval.

# 03-1219 <u>ACCEPTANCE OF GRANT – NEVADA DEPARTMENT OF</u> <u>HUMAN RESOURCES, DIVISION OF CHILD AND FAMILY</u> <u>SERVICES – DISTRICT ATTORNEY</u>

Upon recommendation of Richard Gammick, District Attorney, on motion by Commissioner Galloway, seconded by Commissioner Shaw, which motion duly carried with Commissioner Sferrazza absent, Chairman Humke ordered that the District Attorney's Office be authorized to accept grant funds in the amount of \$149,643 for three years, with a County match of \$12,471 each year, from the Nevada Department of Human Resources, Division of Child and Family Services. # 03-1220 <u>AGREEMENT – CITY OF RENO AND TRUCKEE MEADOWS</u> <u>WATER AUTHORITY – TRUCKEE RIVER KAYAK COURSE</u> <u>PROJECT – PARKS</u>

Sam Dehne, Reno resident, stated he supports the Truckee River Kayak Course Project, but does not support the money coming out of the Question 1 funds. He believes the downtown beneficiaries and the casinos should have provided cash support for the project. County Manager Katy Singlaub clarified that downtown property owners did pledge security for the proposed funding from the Question 1 monies, and the Board did not have the ability to act on the granting of the money from the Question 1 funds until the State issued bonds. The Board did act on it in a timely manner. She said the pledge from the downtown property owners enabled bids to be issued and awarded and construction to begin. She confirmed the public did fund the project from the Question 1 State bond proceeds.

Commissioner Galloway stated he wished there had been a direct contribution from some of the downtown property owners, in addition to a loan. He affirmed this is a worthy project and a good use of the money.

Commissioner Weber said that the media and others have not given recognition to the County for its participation and support of the project.

Upon recommendation of Karen Mullen, Parks and Recreation Director, on motion by Commissioner Shaw, seconded by Commissioner Weber, which motion duly carried with Commissioner Sferrazza absent, it was ordered that an agreement between Washoe County, the City of Reno and the Truckee Meadows Water Authority (TMWA), concerning funds authorized in the November 2002 State Question 1, Parks and Open Space Bond, for the Truckee River Kayak Course Project, in the amount of \$1,500,000, be approved and Chairman Humke be authorized to execute the same.

## 03-1221 <u>APPEARANCE – INTEGRATED CASE MANAGEMENT</u> <u>PROJECT</u>

Kelsey Piechocki, Vice President, Community Resources and Information Services, United Way; Ken Retterath, Adult Social Services Director; and Gabrielle Enfield, Grants Administrator, presented an overview of the Integrated Case Management Business Plan in Washoe County.

Mr. Retterath summarized Integrated Case Management as a single point entry system servicing persons of all ages with a wide range of human service needs in order to coordinate and collaborate on an interagency level across public and private forprofit and nonprofit provider lines to best meet the wide array of service needs in an efficient and effective manner.

In response to Commissioner Galloway, Mr. Retterath confirmed that part of the Integrated Case Management Business Plan is to work with private agencies to assist them in their service to the public.

Commissioner Shaw invited the presenters to return to a future meeting to share additional information, and Chairman Humke suggested the materials be presented to the Board at a workshop.

Bill No. 1403, entitled, "AN ORDINANCE AMENDING WATER ORDINANCE 1189, SEWER ORDINANCE 1210 AND RECLAIMED WATER ORDINANCE 1190, ARTICLE 7, ENTITLED "TIME AND MANNER OF PAYMENT," TO ADD SUBSECTION 7.5A TO PROVIDE FOR THE COLLECTION OF DELINQUENT CHARGES ON THE GENERAL COUNTY TAX ROLL" was introduced by Commissioner Shaw; the title was read to the Board; and direction was given to publish legal notice for final action of adoption.

## 03-1223 <u>UPDATE – VARIOUS BOARDS/COMMISSIONS</u>

Commissioner Galloway reported on fire issues at Lake Tahoe. He stated the Tahoe Regional Planning Agency (TRPA) recently expressed in a workshop that they are in favor of man-made artificial thinning of the forest in the Tahoe Basin. TRPA has come to recognize that the artificial suppression of fires creates an unnatural condition that requires an artificial solution. He said the most recent item that the TRPA accomplished was a resolution in favor of either repealing or modifying the restrictions on the use of mechanical equipment to take excess fuel out of stream environment zones.

Commissioner Shaw summarized a meeting of the School District Bond Oversight Committee that he and Commissioner Galloway attended. He stated this committee is receiving updates from the School District concerning a number of different projects, such as new schools and school renovation. The School District is seeking approval from the committee for bond issues that are forthcoming.

Chairman Humke reported there would be a meeting next week of the Investment Management Committee.

The Chairman opened the public hearing by calling on anyone wishing to speak for or against adoption of said Ordinance. There being no response, the hearing was closed.

County Manager Katy Singlaub acknowledged Bill Mikawa, Manager of Internal Audit, and other people who have participated in the development of the new Ordinance. She said the Ordinance will chart future accountability and sets a new standard of government controls and financial management in Washoe County. She expressed appreciation to the elected department heads who all came together and reached a consensus on supporting the Ordinance. She requested the Board's active support for improving and strengthening audit controls over County government.

On motion by Commissioner Shaw, seconded by Commissioner Galloway, which motion duly carried with Commissioners Sferrazza and Weber absent, Chairman Humke ordered that Ordinance No. 1222, Bill No. 1402, entitled, "AN WASHOE ORDINANCE AMENDING THE COUNTY CODE BY ESTABLISHING THE AUDIT COMMITTEE: PROVIDING FOR THE **COMMITTEE'S MEMBERSHIP AND DUTIES; PROVIDING FOR THE** WRITING, SUBMISSION, REVIEW AND APPROVAL OF AUDIT REPORTS: **PROVIDING FOR THE MANNER OF AUDITING DEPARTMENTS HEADED** BY ELECTED OFFICIALS: REVISING PROVISIONS RELATED TO **CONTRACTS FOR AUDITS; PROVIDING FOR THE SUBMISSION OF AUDIT** SCHEDULES TO THE AUDIT COMMITTEE; ESTABLISHING A PROCESS FOR AUDIT IMPLEMENTATION PLANS AND OTHER MATTERS **PROPERLY RELATING THERETO,**" be approved, adopted and published in accordance with NRS 244.100.
