In response to Chairman Larkin, Mike Sullens, Senior Buyer, replied a consultant was hired to review the requirements for the elevators, who then wrote the regulations ensuring reliability and better service that could prevent future repairs. He said in doing so, the cost had increased for all County elevators. He explained the elevators in the downtown courthouse were under the same provision since they recently came off warranty. Mr. Sullens noted the standard had changed for all 44 elevators located in the County.

Katy Singlaub, County Manager, indicated a national search had been conducted for a Senior Services Director. She explained the department had an interim director, but since this department was an important County operation a permanent replacement needed to be appointed.

In response to Commissioner Galloway, Ms. Singlaub replied the hiring freeze previously implemented by the Board was not a "hard freeze". She explained in the past many adjustments had been made to that freeze based on the demands of the department. Ms. Singlaub remarked this position was advertised nationally prior to a more rigid hiring freeze being implemented, but agreed positions that could be held open continue to be for as long as possible. She said the Senior Services Department had a high service level that included many volunteers, contractors and daily food service making the Department a critical operation and an important role in the community.

Chairman Larkin asked how would this appointment differentiate from other appointments. Ms. Singlaub replied that would depend whether the County had the capacity organizationally to cover the functions in the absence of a director. She added from a service level, significant responsibilities and liabilities in the area of Senior Services determined that this position needed to be filled.

Commissioner Galloway said because Senior Services received many federal grants, would it be less sensitive to the revenue drops and/or the County General Fund. Ms. Singlaub replied because it was primarily funded by a dedicated property tax rate, ad valorem rate and federal and state grants as well as substantial donations it was less sensitive. Commissioner Galloway remarked since this did not set a policy by implication for other director vacancies he would support the appointment.

In response to the call for public comment, Sam Dehne remarked on the qualifications and attributes for a Senior Services Director.

On motion by Commissioner Galloway, seconded by Commissioner Jung, which motion duly carried with Commissioner Weber absent, Chairman Larkin ordered that Agenda Item 7J be approved.

## 07-1243 <u>AGENDA ITEM 8 - LIBRARY</u>

<u>Agenda Subject</u>: Recommendation to appoint one individual to the vacant Washoe County Library Board of Trustees seat, with a term effective October 23, 2007 to June 30, 2011.

Commissioner Galloway disclosed he had spoken to appointee Johnnie Pullman to see if she would seek reelection to the Washoe County School Board in which she replied she would.

Commissioner Humke moved to appoint Fred Lokken to the Washoe County Library Board of Trustees. Chairman Larkin seconded the motion.

Upon discussion, Commissioner Galloway stated he was leaning toward appointing Ms. Pullman. Commissioner Jung also indicated she would recommend appointing Ms. Pullman for the Trustee position.

Commissioner Humke amended the motion and moved to continue this item until November 13, 2007 when there would be a full Board. The seconder agreed.

On call for the vote, the amended motion passed 4 to 0 with Commissioner Weber absent.

#### 07-1244 AGENDA ITEM 9 - RISK MANAGEMENT

<u>Agenda Subject</u>: Recommendation to approve payment of the estimated annual assessment for Washoe County's self-funded workers' compensation program for Fiscal Year 2007/2008 to the State of Nevada, Division of Industrial Relations, [in four installments of \$35,014.71 each, for a total of \$140,058.85].

Katy Singlaub, County Manager, indicated these were not discretionary expenditures, but a required payment the County made to the State.

Chairman Larkin asked why the States' cost increased 13.7 percent and the County's annual claim expenditures increased 16 percent. Jim Jeppson, Risk Manager, replied the Director of Industrial Relations (DIR) had a number of required operations funded by this assessment. He said the State Legislature reviewed and approved their budget enabling him to break down the cost increases among the various operations of the DIR; however, he would locate that information and return to the Board with that data. He said the biggest cost category continued to be the heart/lung claims for sheriff deputies. Mr. Jeppson indicated that was the largest single worker's compensation expense for any public entity that had police officers or firefighters. He stated during the

past three years, in which this assessment was based, 18 new heart claims had been accepted by the County. Mr. Jeppson explained the claims increased due to the testing becoming more comprehensive. He noted the medical conditions were being aggressively treated and explained prescription drugs, especially heart drugs, were expensive. Mr. Jeppson commented there was also an increase in the statutory compensation rate for loss time by legislative formula every year. He explained the compensation rate formed the basis for every payment made to an injured worker. Mr. Jeppson noted another significant factor was the adoption by the DIR of the fifth addition of the *American Medical Association Guides To The Evaluations Of Permanent Impairment*, which was used by rating physicians to establish a permanent disability. He said by adding a new factor this addition increased the ratings on back claims 60 percent. Mr. Jeppson acknowledged ratings were also added for subjective pain complaints and an activity factor for daily living, which were now compensatible under worker's compensation.

Commissioner Galloway asked if law enforcement was under a different standard and did they get presumption. Mr. Jeppson replied the presumption became effective in 1988 and that Nevada had a law that established conclusive presumption for police officer's and firefighters if they contracted any form of heart or lung disease that was conclusively presumed to have occurred on the job.

In response to the call for public comment, Sam Dehne voiced his opinion of the State Worker's Compensation benefits.

On motion by Commissioner Jung, seconded by Commissioner Galloway, which motion duly carried with Commissioner Weber absent, Chairman Larkin ordered that Agenda Item 9 be approved.

#### 07-1245 AGENDA ITEM 12 - PUBLIC WORKS DEPARTMENT

Agenda Subject: Recommendation to accept donations [\$447,500] and award bid for "District Attorney C.A.R.E.S./S.A.R.T. facility" to the lowest, responsive and responsible bidder [staff recommends Building Solutions LLC \$1,125,265]; and if awarded, authorize Chairman to execute contract documents upon presentation; and direct Finance to make necessary adjustments.

Richard Gammick, District Attorney, conducted a PowerPoint presentation, which was placed on file with the Clerk, highlighting the Sexual Assault Response Team (S.A.R.T) and Child Abuse Response Evaluations (C.A.R.E.S) program's history, groundbreaking and finances. He recognized the following organizations for their contributions:

Washoe County Sheriff's Office Washoe County School District Police Department Washoe County Social Services Washoe County District Health Department University of Nevada, Reno, Police Department Reno Police Department Sparks Police Department Northern Nevada Medical Center Crisis Call Center

Mr. Gammick said this facility would service northern Nevada, all the contiguous northern California counties and Washoe County. He explained the other counties would be charged a fee to defray the cost; however, law enforcement agencies would not be charged.

Commissioner Jung commended Mr. Gammick and stated this service was needed in the community and would bring a level of compassion to the victims.

On behalf of the Board, Commissioner Galloway thanked the donors for their generous donations for the C.A.R.E.S/S.A.R.T facility.

In response to the call for public comment, Sam Dehne commended the program and the donors.

Chairman Larkin disclosed he sat on the Northern Nevada Medical Center Board.

On motion by Commissioner Humke, seconded by Commissioner Galloway, which motion duly carried with Commissioner Weber absent, Chairman Larkin ordered that Agenda Item 12 be accepted, awarded, authorized, executed and directed.

Agenda Subject: Recommendation to award Invitation to Bid # 2582-07, A Stocking & Inventory Program for Water Meters Boxes, Touch Read Lids and Misc. Water Work Supplies, to the only responsive bidder, Western Nevada Supply Co. [approximately \$120,000]. Since these items are used in new construction, renovation and maintenance of water lines throughout Washoe County exact requirements are unknown. This award shall run from the date of Bid Award through December 31, 2009 with Washoe County retaining option for a one-year extension, provided prices do not increase and service is satisfactory. (All Districts).

In response to Commissioner Galloway, Mike Sullens, Senior Buyer, replied the County had a contract for three years that expired recently for Water Meter Boxes, and Touch Read Lids where the prices were set. He said in the new contract the average price had increased 16.38 percent. He explained the County received excellent service from this vendor and staff felt the pricing was reasonable. Commissioner Galloway indicated there were three items that increased significantly. He asked rather than being locked in on those three items, could staff investigate alternatives allowing the Board to exclude those and award the remaining items. Mr. Sullens replied this was composed as a package, and he would need to check with the vendor in order to remove some of the items. Mr. Sullens suggested awarding the bid as a package; however, staff would follow-up with the vendor to inquire those questionable items.

There was no response to the call for public comment.

On motion by Commissioner Galloway, seconded by Commissioner Jung, which motion duly carried with Commissioner Weber absent, Chairman Larkin ordered that Agenda Item 13 be awarded.

Agenda Subject: Recommendation to authorize Chairman of the Board of County Commissioners to sign the Resolution Adopting the Amended South Valleys Area Plan (CP05-004), as to the areas known as Steamboat and Pleasant Valleys, a part of the Washoe County Comprehensive Plan, such signature by the Chairman to be made only after a determination of conformance with the Regional Plan by the Truckee Meadows Regional Planning Agency.

Katy Singlaub, County Manager, explained the County previously carved this area out of the South Valleys Area Plan; however, the remainder of that Plan was being brought back to the Board. She stated this went forward as approved and noticed to the public specific to the Steamboat and Pleasant Valleys.

There was no response to the call for public comment.

On motion by Commissioner Galloway, seconded by Commissioner Jung, which motion duly carried with Commissioner Weber absent, Chairman Larkin ordered that Agenda Item 16 be adopted and authorized. See Resolution attached hereto and made a part hereof.

## 07-1250 AGENDA ITEM 15 - COMMUNITY DEVELOPMENT

Agenda Subject: Development Code Amendment Case Number DCA07-008-Introduction and first reading of an Ordinance amending provisions relating to Washoe County Code Chapter 110, Article 306 by clarifying a maximum of two plumbing fixtures allowed in detached accessory structures, and other matters properly relating thereto.

In response to Chairman Larkin, Roger Pelham, Senior Planner, explained it was past practice to limit the number of plumbing fixtures to two in a detached accessory structure. He commented this was an artifact of the Uniform Building Code (UBC) that Washoe County no longer operated under. He explained the County now operated under the International Building Code (IBC), which was silent to the number of fixtures that constitute a structure as opposed to a dwelling. Mr. Pelham remarked this could apply to everyone who applied for a permit for a garage and be clearly codified that there could be two plumbing fixtures in a detached structure. Chairman Larkin asked how the County decided on two fixtures. Mr. Pelham reiterated it was an artifact of the UBC that three or more plumbing fixtures were a characteristic of a dwelling as opposed to two or fewer being a structure.

Commissioner Galloway stated there was a set policy where there could be a secondary residential unit, but the intent of this bill was to ensure that single-family zoning was not being violated. Mr. Pelham agreed. Chairman Larkin said there was nothing that would prevent someone from establishing a business and apply for a variance under a Special Use Permit (SUP). Mr. Pelham replied if a business were established that required a SUP or another type of discretionary action this restriction would not apply. Chairman Larkin stated it would apply, but they would need to apply for a SUP. Mr. Pelham said if a SUP for a particular type of commercial activity was requested then this would not apply. He said the County never applied that limit of plumbing fixtures to a commercial structure. Chairman Larkin said if someone was putting a structure on their residence it would not be in a commercial zone, and if they wanted to place a structure that had three plumbing fixtures, they would have to come in and apply for a SUP. Mr. Pelham concurred.

Commissioner Humke asked how bids for hoses were treated under attached accessory structures. Mr. Pelham replied they were part of the utility development of the parcel.

In response to the call for public comment, Gary Schmidt remarked on detached accessory structures.

Agenda Subject: Recommendation to accept the Sierra Front Working Group work-plan; authorize County staff to devote time to the effort; dedicate \$5,000 to the initial cost for a community-wide education and awareness program; as funds become available, contribute a minimum of \$50,000 for the installation of wildlife proof trash enclosures at Davis Creek Park; and offer County staff guidance on funding, potentially dedicating revenue from increasing park usage fees in conjunction with the increase in trash expenses.

Dave Childs, Assistant County Manager, reviewed the Board's direction given to staff during the September 11, 2007 meeting, which was to reconvene the Bear Working Group, to put together a work plan dealing with bear issues, funding alternatives for communication, and bear-proof containers. He indicated the Bear Working Group reconvened and the agencies involved in that Group were: the Nevada Department of Wildlife (NDOW), Washoe County Animal Control, Washoe County Community Relations, Community Development Department, the Washoe County Sheriff's Office

(WCSO), the County Manager's Office, Douglas County Code Enforcement, Incline Village General Improvement District (IVGID), Waste Management, and the Washoe County District Health Department, in addition staff had made inquiries to Carson City and the City of Reno. Mr. Childs stated the Sierra Front Bear Working Group 2007/08 Work Plan distributed to the Board and placed on file with the Clerk, highlighted the purpose, goal, measurement and methods of the Working Group. He stated the Board asked for several items in relation to funding such as a public information campaign. Mr. Childs explained the request for \$5,000 was to begin that campaign. He said the previously approved additional \$2 per night campground fee at Davis Creek Park, should be recommended toward bear-proof containers for that Park. He said staff would like the Board to adopt the Plan, direct staff to work with the agencies to implement the Plan, and consider funding an advertising and education campaign for the public.

Doug Doolittle, Regional Parks and Open Space Director, stated an appropriate use of the additional \$2 campground fee for Davis Creek Park would be toward food storage containers for that Park.

Mr. Childs demonstrated how the bear-proof container operated and noted there was a child safety latch located inside the container.

Commissioner Humke asked if the containers were currently being manufactured or were they a prototype. Mike Genera, Waste Management, replied they were currently manufactured and previously tested in Telluride, Colorado.

Commissioner Galloway asked if the education program would include a video that could be played on Sierra Nevada Community Access Television (SNCAT) and other public television stations. Mr. Childs stated this would be a multi-media approach. Commissioner Galloway inquired if the requested \$50,000 would be appropriated out of contingency or approve a plan by which \$50,000 would be spent and recovered by fees from certain campgrounds. Mr. Childs suggested the containers be approved and the County be reimbursed from the campground fees for approximately five years. Commissioner Galloway said then the motion should be to contribute \$50,000 out of a source to start a fund for bear-proof containers, which would be replenished by fees at certain campgrounds.

Mr. Childs clarified the \$50,000 indicated in the staff report was needed for food storage containers at Davis Creek Park. Mr. Doolittle explained there were currently locked trash containers at the Park for group use.

Chairman Larkin asked if there was a message to be conveyed to the public about feeding wildlife and the law of intermittent reinforcement. Mr. Childs said a no-feeding ordinance was needed to prohibit the public from feeding wild animals and indicated an ordinance would be coming before the Board in the future.

Katy Singlaub, County Manager, said the Board had appropriately identified that the contingency fund could be a source for the funding, but contingency

allocations had to be separately noticed on the agenda. She said during the first November Board meeting there would be recommendations for budget reductions. She asked that the park fee and the budget reductions for uses in other departments be discussed before definitive commitments were made for funding from a specific source. Chairman Larkin agreed and said the commitment of \$50,000 would not be made at the present time.

Commissioner Galloway requested when funding was discussed that separate or revolving funds for education and park facility improvements be included.

Commissioner Humke commented it was important to have a public information and education effort to make the public aware of the upcoming changes.

In response to the call for public comment, Gary Schmidt spoke on the "buddy system" when hiking in the outdoors.

On motion by Commissioner Humke, seconded by Commissioner Galloway, which motion duly carried with Commissioner Weber absent, Chairman Larkin ordered that Agenda Item 17 be accepted, directed and the \$5,000 from the Regional Parks and Open Space funds be approved.

Commissioner Humke explained that the RTC staff made a recommendation for an increase; however, staff had delayed increases for several years and then without regard to economics or the effect on the business community, recommended a large increase. He said the RTC took a reasonable approach and voted to make this increase and revisit this issue approximately 12 months from the date of the original increase. Commissioner Humke said the RTC was also reviewing additional revenue sources to fund transportation, which would be an important dialogue to involve the community since there would be at least four major authorizations for spending competing in the County on the next ballot. He commented it was important to stage the increases.

Commissioner Galloway stated he would support a motion even though this was not brought to the Board in smaller increments. He indicated he would have gone farther than the proposed 50 percent; however, any increase was better than no increase. He believed if the fee was not brought up to reflect the full cost of road construction before the next elections and the voters did not vote for anything more concerning transportation because they felt it was an attempt to relieve developers of a burden, it could place the burden on the general population in the form of another tax.

Commissioner Jung stated she valued Mr. Purdy's input, but the County needed to be careful on dramatically raising impact fees since those fees could be passed to home buyers and the County needed to be mindful of affordable housing.
