He suggested the RSCVA refinance bonds and spread the debt over a longer period of time. Mr. Kozera agreed with comments he attributed to Reno City Councilmember Dave Aiazzi that the golf courses should manage themselves.

Sam Dehne talked about the University of Nevada Reno's football team and mentioned the upcoming retirement of local newspaper columnist/pundit Cory Farley. He expressed disagreement with State budget cuts.

Agenda Subject: "Consideration of proposals for operation of Reno, Washoe County and Reno Sparks Convention and Visitors Authority golf courses; and, possible direction to staff concerning same."

Doug Doolittle, Director of Washoe County Regional Parks and Open Space, provided a brief overview of the process to solicit proposals for the operation and management of five golf courses, as outlined in the staff report. He pointed out the proposals were recently considered at November 2007 meetings of the Reno City Council, Board of County Commissioners, and Reno Sparks Convention and Visitors Authority (RSCVA). He stated that, of the seven proposals submitted, six identified various management fee arrangements that would increase the cost of operating the golf courses. On behalf of the joint staff, Mr. Doolittle requested the rejection of all proposals received by the three agencies.

The joint Board members waived any formal staff presentation.

In response to the call for public comment, Ray Isernhagen and Sam Dehne spoke in favor of maintaining the current management status for the golf courses.

For Washoe County, on motion by Commissioner Galloway, seconded by Commissioner Weber, which motion duly carried, it was ordered that the proposals submitted for Agenda Item 6 be rejected as recommended in the staff report.

For the City of Reno, on motion by Councilmember Zadra, seconded by Councilmember Hascheff, which motion duly carried with Councilmembers Aiazzi and Dortch absent, it was ordered that the staff report be accepted and the proposals submitted for Agenda Item 6 be rejected as recommended in the staff report.

For the Reno Sparks Convention and Visitors Authority, on motion by Director Cartlidge, seconded by Director Baldwin, which motion duly carried with Directors Dortch, Farahi and Pardue absent, it was ordered that the proposals submitted for Agenda Item 6 be rejected as recommended in the staff report.

Ellen Oppenheim, President/CEO of the RSCVA, thanked those who submitted proposals for their time, thoughtfulness and suggestions. She also thanked County, City and RSCVA staff members for their tremendous effort during a compressed time frame.
