He congratulated all the newly elected GID members and stated the GID's represented the most efficient levels of government in Washoe County. He said he was opposed to consolidation because any economies of scale that might be gained would be lost by taking government further away from the people. He suggested the Citizen Advisory Boards should be given more authority.
