SUMMARY

The District Attorney's Office is has renovated the McGee Center and is operating the Washoe County Child Advocacy Center.

Strategic Objectives supported by this item: Safe Secure and Healthy Communities

PREVIOUS ACTION

May 13, 2014: The Board of County Commissioners accepted \$860 in donation for the District Attorney's Office Child Advocacy Center remodel, equipment, and operations from the Victim Witness Assistance Center.

March 25, 2014: The Board of County Commissioners accepted \$10,000 in donation for the District Attorney's Office Child Advocacy Center remodel, equipment, and operations from the Robert S. & Dorothy J Keyser Foundation.

March 11, 2013: The Board of County Commissioners accepted \$80,000 in donation from the Marie Crowley Foundation (\$20,000) and the William N. Pennington Foundation (\$60,000)

February 11, 2013: The Board of County Commissioners accepted \$140,350 in donation from Knights of St. John (\$30,000); Mathewson Charitable Lead Trust One (\$25,000); Mathewson Charitable Lead Trust Two (\$35,000); Hart Foundation (\$15,000); Joey



Gilbert, Esq. (\$250); Bretzlaff Foundation (\$25,000); Michael Bolton Charities (\$10,000); and Carlee Ferrari (\$100)."

December 17, 2013: The Board of County Commissioners awarded a bid and approved the Agreement to the lowest responsive, responsible bidder for the McGee Center Remodel Project recommended [Q & D Construction, \$285,770.00].

December 17, 2013: The Board of County Commissioners approved transfer from Other Restricted Revenue Fund (CARES/SART Donations - IO 120327), to the Capital Improvement Fund for the McGee Center for the District Attorney's Office Child Advocacy Center remodel (total project no to exceed \$450,000), and accept donation for the project from the E.L. Cord Foundation (\$65,000) and from the Roxie & Azad Joseph Foundation (\$25,000).

October 8, 2013: The Board of County Commissioners accepted donations of furniture from Department of Homeland Security [valued at approximately \$40,000] and connectivity/wireless backbone equipment from Community Chest [valued at \$24,400.01] for the Washoe County District Attorney's Office CARES/SART Program and Child Advocacy Center

BACKGROUND

The mission of the Washoe County Child Advocacy Center will be to ensure the health and safety of the child through a neutral, child-centered environment designed to minimize trauma to the child, provide advocacy for the child and non-offending caregivers and support effective investigations. Local organizations continue to donate to the Child Advocacy Center to help with equipment and operational needs.
