May 16, 2006 – The Board of County Commissioners approved the appointment of Elaine Carrick to serve as a member of the Animal Control Board.

BACKGROUND

The Animal Control Board was established by County Code to approve, suspend and revoke exotic animal, cattery permits and kennel permits within Washoe County, including the City of Reno and the City of Sparks.

In accordance with Washoe County Code Chapter 55.030, the Board of County Commissioners appointed members to the Animal Control Board including one member each to represent the five County Commission Districts and one representative of a society for the prevention of cruelty to animals and one member having experience or qualifications with exotic animals.

On April 13, 2014 Elaine Carrick, representative from a society for the prevention of cruelty to animals, completed her four-year term on the Animal Control Board.

In May 2014 and January 2015 announcements were sent to the public advising there was an open seat on the Animal Control Board. Elaine Carrick desired to continue serving on the Board and re applied. Through the selection process Mrs. Carrick was the applicant that met the requirements of WCC55.030.

FISCAL IMPACT

RECOMMENDATION

It is recommended that the Board of County Commissioners approve the reappointment of Elaine Carrick, representative from a society for the prevention of cruelty to animals, to the Animal Control Board for an additional 4-year term.
