BACKGROUND

The Government Finance Officers Budget Awards Program is designed to encourage governments to prepare budget documents of the highest quality to meet the needs of decisionmakers and citizens. This award represents a significant achievement for Washoe County and reflects our commitment to meeting the highest principles of governmental budgeting. In order to receive the budget award, Washoe County had to satisfy nationally recognized guidelines for effective budget presentation. Those guidelines are designed to assess how well Washoe County's budget serves as a policy document, a financial plan, an operating guide, and a communications devise. This is the 13th year that the award has been received by Washoe County.
