

SUBJECT:	Approve re-appointment of Sarah Chvilicek to the Washoe County Planning Commission, on the recommendation of the Washoe County Commission Chair, to represent Commission District 5 on the Planning Commission for a term beginning on July 1, 2015, and ending on June 30, 2019, or until such time as a successor is appointed. (Commission District 5.)

## **SUMMARY**

Sarah Chvilicek was appointed by the Board of County Commissioners (Board) to fill an unexpired term on the Washoe County Planning Commission. The term began on October 22, 2013 and will expire on June 30, 2015. County Commissioner Jeanne Herman has recommended Sarah Chvilicek to the Chair of the Washoe County Commission to be considered for reappointment to the Planning Commission. If reappointed, the term will begin on July 1, 2015, and end on June 30, 2019, or until such time as a successor is appointed.

Washoe County Strategic Objective supported by this item: Public participation and open, transparent communication.

## PREVIOUS ACTION

On October 22, 2013, the Board appointed Sarah Chvilicek to the Washoe County Planning Commission to fill an unexpired term.

## **BACKGROUND**

Nevada State Law requires Washoe County to create a Planning Commission to adopt the County's Master Plan and to provide other land use duties as established in County codes. The Board established the Planning Commission to hear and decide on applications for abandonments, certain special use permits, and tentative subdivisions; and, to hear and make recommendations to the Board concerning amendments to the County's Master Plan and the Development Code (Washoe County Code Chapter 110), adopted Regulatory Zoning maps, and Development Agreements. Terms of appointment



are four years and the appointees must be residents of the unincorporated area of Washoe County and registered voters at the time of their appointment and throughout their term of office. The Board appoints seven members to the Planning Commission as follows:

- Five members representing each of the County Commission Districts;
- One member from north of the Truckee River; and,
- One member from south of the Truckee River.

Based on direction previously provided by the Board, the Commissioner whose district is represented by the Planning Commission vacancy, (Commission District 5 in this case) recommends the appointment. Commissioner Herman recommends that Sarah Chvilicek be reappointed to a full term to the Planning Commission commencing on July 1, 2015, through June 30, 2019, or until such time as a successor is appointed. Ms. Chvilicek has not completed a full membership term on the Planning Commission and is eligible for reappointment. Ms. Chvilicek is willing to be reappointed to the Planning Commission. She updated her current application, which is included as Exhibit A to this staff report.

WCC Section 110.912.05(c)(1) requires that the Chairman of the Board appoint, subject to the approval of the Board, members of the Planning Commission.

## FISCAL IMPACT

As authorized by NRS 278.040(3) and Washoe County Code Section 110.912.05(e), the Planning Commission members receive an \$80 per meeting stipend. The Planning Commission is required by Nevada Revised Statute to meet monthly, which equates to an annual per member stipend of \$960. Funds to compensate all Planning Commission members for scheduled meetings were approved as part of the FY 2015-2016 budget of the Planning and Development Division, Community Services Department (account 105400-710110).

## **RECOMMENDATION**

It is recommended that the Board of County Commissioners approve re-appointment of Sarah Chvilicek to the Washoe County Planning Commission, on the recommendation of the Washoe County Commission Chair, to represent Commission District 5 on the Planning Commission for a term beginning on July 1, 2015, and ending on June 30, 2019, or until such time as a successor is appointed.

## **MOTION**

Should the Board agree with staff's recommendation, a possible motion would be: "Move to approve re-appointment of Sarah Chvilicek to the Washoe County Planning Commission, on the recommendation of the Washoe County Commission Chair, to represent Commission District 5 on the Planning Commission for a term beginning on July 1, 2015, and ending on June 30, 2019, or until such time as a successor is appointed."
