SUMMARY

This item recommends the Board appoint an individual representing Washoe County from the business sector to the Western Nevada Development District for a term of two (2) years. The appointment would be effective August 1, 2015 and expire on June 30, 2017. Staff has received two (2) applications for consideration to the appointment.

BACKGROUND

Western Nevada Development District (WNDD) was incorporated as a Nevada Non-Profit Corporation in November 1983 and designated by the U.S. Economic Development Administration as an Economic Development District (EDD) in 1984. The original four counties were Carson City, Douglas, Lyon and Storey. In the late 1980's Churchill, Pershing and Mineral were added. The following counties became part of the EDD recently: Humboldt, 2011 and Washoe, 2012. WNDD works with public and private entities to promote collaboration to address economic development issues throughout the region.

WNDD allows for three (3) representatives from each entity to be appointed to their Board of Directors. Ideally, the three representatives would be comprised of a County Commissioner, business representative and appropriate staff from within the County. Washoe County is currently represented on the WNDD Board of Directors with Commissioner Kitty Jung as well as Al Rogers, Management Services Director. The Commissioner and staff have both attended meetings and events for the past year and more.

It is anticipated this appointed business sector individual along with the new Business Facilitator staff position in the Community Services Department could complete the three (3) members representing Washoe County to the Western Nevada Development District.

It is recommended that the Board of County Commissioners appoint Sylvia Woods or Jenifer Rose as a board member of Western Nevada Development District representing Washoe County from the business sector with a term that would be effective August 1, 2015 and expire June 30, 2017.
