The Animal Control Board was established by County Code to approve, suspend and revoke exotic animal, cattery permits and kennel permits within Washoe County, including the City of Reno and the City of Sparks. In accordance with Washoe County Code 55.030, the Board of Commissioners appointed members to the Animal Control Board including one member each to represent the five County Commission Districts and one representative of a society for the prevention of cruelty to animals and one member having experience or qualifications with exotic animals.

The appointed representative serves a four-year term on the Animal Control Board.
