The Washoe County Board of Commissioners convened at 10:00 a.m. in regular session in the Commission Chambers of the Washoe County Administration Complex, 1001 East Ninth Street, Reno, Nevada. Following the Pledge of Allegiance to the flag of our Country, the Clerk called the roll and the Board conducted the following business:

16-0647 AGENDA ITEM 3 Public Comment.

Rick Snow spoke about the burned out trailer located at 275 Magnolia Way. He stated the deceased property owners' daughter-in-law maintained the taxes on the property and had not accepted certified mail from the County regarding the property. He hoped the County would place the issue on an agenda and proceed with probate. He mentioned the City of Reno's recent decision to demolish structures on two properties and he asked whether the County could take a similar action.

Elise Weatherly inquired as to why Pastor Marvin Neal was uninvited from the Jan Evans Juvenile Justice Center. She spoke about the Bible not being allowed to be a part of the government due to the fear of lawsuits. She asked that the ministry be allowed back into the youth facility.

Sam Dehne spoke about the City of Reno's need for more schools and the school tax bond issue on the ballot.

Pee Wee Henson expressed his appreciation for the Board's work on the congested area map.

John Slaughter, County Manager, stated there was a need to remove Consent Agenda Items 5I and 5J1. He noted Consent Agenda 5J1 was being removed because the County had not received the final documents. He mentioned Commissioners Lucey and Herman were attending a National Association of Counties (NACo) conference.

Commissioner Hartung requested a timeline for the completion of single-stream recycling. He also requested staff to provide the Board with options regarding the traffic issues on Nicole Drive.

Chair Jung announced the County won a national award from the NACo for its Crossroads Program, which was the brainchild of Kevin Schiller, Assistant County Manager, when he was the Director of Social Services. She thanked the Communications team for submitting an entry on behalf of the Crossroads Program.

Mr. Slaughter explained the County applied for the NACo Achievement Award in the category of Human Services. The award received by the County was for Best of Category.

AGENDA ITEM 6 Presentation: Western Nevada Development District, Ronald J. Radil, Executive Director. [10 minutes.]

Ronald J. Radil, Western Nevada Development District (WNDD) Executive Director, conducted a PowerPoint presentation. The headings of the slides were as follows: 1) Western Nevada Development District. 2) About Western Nevada Development District. 3) Western Nevada Development District Projects. 4) Western Nevada Development District Comprehensive Economic Development Strategy and Goals. 5) Western Nevada Development District CEDS and Community Benefits. 6) Western Nevada Development District CEDS and USDA Rural Development Applications. 7) Western Nevada Development District Programs and Services. 8) Western Nevada Development District Benefits. 9) WNDD Contact Information.

Commissioner Berkbigler noted the importance of the need for local governments in the region to work collaboratively in order to compete at the national level.

In connection to Commissioner Berkbigler's comments regarding the need for local governments to work together as a region, Mr. Radil mentioned a speaker, at an upcoming conference, would address the Sierra Pacific Megapolitan Region, which was an area identified to include the Bay Area to Washoe County.

Commissioner Berkbigler added the Tahoe Regional Planning Agency and the Tahoe Transportation District routinely discussed the impact that people, who lived outside the Lake Tahoe Basin, had on Lake Tahoe. She remarked all of the governments in the region needed to come together to ensure Lake Tahoe's protection.

There was no public comment or action taken on this item.

AGENDA ITEM 13 Recommendation and possible action to introduce and conduct first reading of an ordinance amending Washoe County Code Chapter 110 (Development Code) to clarify when an accessory structure or use may be constructed on a parcel without an existing main structure or an existing principal use. The amendment focuses on circumstances where the subject parcel is adjacent to a parcel with an existing main structure or principal use and when both parcels are under the same ownership. The amendment includes updates to the following sections of the Development Code: Article 306, Accessory Uses and Structures, Section 110.306.15, Main Structures Required - to identify the circumstances under which an accessory structure or use may be established on a parcel without an existing main structure or an existing principal use. Article 410, Parking and Loading, Section 110.410.20, Location of Required Parking Spaces – to clarify that a dwelling's required garage may only be located on an adjoining lot if it also meets the requirements of Section 110.306.15. Article 902, Definitions, Section 110.902.15, General Definitions – to update definitions for "Detached

accessory structure," "Lot" and "Parcel of land" to better reflect the proposed code amendments identified above. And, if supported, set the public hearing for second reading and possible adoption of the Ordinance for August 9, 2016. Community Services. (All Commission Districts.)

The Chair opened the public hearing.

Jan Galassini, Chief Deputy County Clerk, read the title for Bill No. 1768.

The Chair called on anyone wishing to speak for or against adoption of said Ordinance. There being no response, the hearing was closed.

Commissioner Hartung asked what precipitated the issue.

Kelly Mullin, Community Services Department (CSD) Planner, replied there was not a specific issue precipitating the change. She explained the amendment would allow the CSD to clarify and codify information within the Code and also allow the CSD to establish a mechanism for preventing non-conformance situations.

Bill No. 1768 was introduced by Commissioner Hartung, and legal notice for final action of adoption was directed.
