**SUBJECT:** Accept funding for reimbursement [\$15,972.87, no County match required] from the Office of Criminal Justice Assistance through the Sparks Police Department for reimbursement of overtime costs associated with the Regional Gang Task Force activities involving the Adam Walsh Compliance project. Grant period is retroactive from 10/15/14 - 9/3/15; and authorize Comptroller's Office to make the appropriate budget adjustments. (All Commission Districts.)

# **SUMMARY**

The Sparks Police Department received an award in the amount of \$100,058.31. They allocated a portion of this funding to cover our overtime costs associated with the implementation of their project. This funding covered overtime costs for deputies that worked with the Regional Gang Task force while engaged in task force activities involving the Adam Walsh Compliance project. These funds are being submitted retroactively due to an error that inadvertently excluded this award from the Sheriff's Office fiscal year 2014-15 BCC submissions. All activities are complete and all expenses have been reimbursed, this staff report is to formalize the budget authority for fiscal year 15/16.

The Sparks Police Department received grant funding to implement specific activities involving the Regional Gang Unit in our area. They provide part of that funding to our agency to cover overtime costs associated with work on the task force.

## FISCAL IMPACT

In fiscal year 14/15 a total of \$7,503.05 was expended and reimbursed. In fiscal year 15/16 a total of \$8,469.82 was expended and reimbursed. Total expenditure for the entire grant period was \$15,972.87. This funding is on a reimbursement basis. No match required.

If approved, a fiscal year 15/16 budget adjustment is required to increase by \$8,469.82 both revenues and expenditures in the following accounts:
