SUMMARY

The Washoe County Sheriff's Office Citizen Corps Program has received a donation in the amount of \$750.00 for their volunteer efforts at the National Championship Air Races, a community event held September 14 through 20, 2015. This donation will go to support the Citizen Corps Programs (CCP), whose volunteer teams include the Community Emergency Response Team (CERT), Sheriff's Mobile Auxiliary Response Team (SMART), Citizen's Homeland Security Council (CHSC) and the Terrorism Liaison Officer Volunteer (TLOV) program.

These funds are intended to be used to support the CCP teams, including but not limited to the purchase of equipment, supplies, food and beverage to be used in emergency response, training, drills or rehab during disasters, and items that can be sold to the volunteers to raise additional funds to support the Citizen Corps Programs.

PREVIOUS ACTION

The Board of County Commissioners approved a donation to the Citizen Corps Program from the Reno Air Race Association on 1/8/13, 1/28/14 and 1/13/2015.

BACKGROUND

The Washoe County Sheriff's Office has a robust Citizen Corps Volunteer Program that is supported primarily by grants and donations. These funds will be used to support the programs.
