- SUBJECT: Introduction and first reading of an ordinance amending Chapter 50 of the Washoe County Code (Public Peace, Safety and Morals), amending Section 50.092 Unlawful Discharge of Firearms; Exemption; amending Section 50.096 Greater Truckee Meadows and environs Congested area and incorporating the Old Washoe City Congested area into the Greater Truckee Meadows and environs Congested area; 50.104 Spanish Springs area Congested area, 50.108 New Washoe City Congested area; Eliminating 50.110 Old Washoe City Congested area; to update the congested areas and associated maps; and providing for other matters properly relating thereto; and if supported, set the public hearing for second reading and adoption for July 12, 2016. (All Commission Districts.)

SUMMARY

The Community Services Department has initiated proceedings to amend the Washoe County Code (Chapter 50 – Public Peace, Safety and Morals) as requested by Commissioner Berkbigler and Jung at the June 23, 2015, County Commission meeting to address concerns of public safety related to the current Firearm Congested Area Boundary last updated in 2002.

The proposed County Code amendment will extend the boundary of the Washoe County "congested area" where uncontrolled discharge of firearms is not permitted as it would result in the greatest risk of injury to life and limb. Due to increased construction activity, annexations by the City of Reno, and implementation of planned outdoor recreation trails and roadways, the current congested area boundary has been determined to be inadequate.

Strategic Objective supported by this item: Safe, secure and healthy communities.

PREVIOUS ACTION

July 28, 2015, the Board of County Commissioners (Board) approved a request to initiate proceedings to amend Washoe County Code (Chapter 50 – Public Peace, Safety and

Morals) pursuant to a request by Commissioner Berkbigler; and directed the County Clerk to submit the request to the District Attorney for preparation of a proposed ordinance, pursuant to Washoe County Code Section 2.030 and 2.040.

August 26, 2014, the Board adopted an ordinance, amending Sections 50.090 and 50.092 of Chapter 50 of the Washoe County Code (Peace, Morals and Public Safety) to remove certain restrictions on the discharge of firearms in portions of Warm Springs.

December 2002 - The Firearm Congested Area Boundary was adjusted by the Board of County Commissioners.

BACKGROUND

Pursuant to Washoe County Code (WCC) section 2.030, amendments to the Washoe County Code must be initiated by a request from the head of a department of the County to the County Clerk. Upon receiving the request, the County Clerk, under WCC 2.040, places the request on an agenda for consideration by the Board who would consider the request (and may hear testimony from the proposer or any other person regarding the proposed changes), and by a majority vote of the members present at the meeting, may approve the request with any changes the Board desires. The Board approved this request on July 28, 2015 and directed the County Clerk to submit the request to the District Attorney for preparation of a proposed ordinance, and, under WCC 2.050, when the District Attorney has completed the proposed ordinance the County Clerk would put the proposed ordinance on the agenda for the next regularly scheduled meeting of the Board in accordance with the adoption procedures set out in NRS 244.100.

Residential areas within Washoe County, and areas annexed by the cities of Reno and Sparks have grown substantially since the last Firearm Congested Area Boundary adjustment in 2002 and need to be adequately captured. Additionally, outdoor recreational opportunities within Washoe County have increased and have created areas of conflict between users of trails and unsafe recreational shooting. These areas of conflict can be mitigated if the Firearm Congested Area Boundary is clear for all users of Washoe County open space. To address this in the most prominent area of the county with trail and recreational shooting conflicts, Peavine Mountain, the proposal includes utilizing the main roadway to the peak as the boundary. It is hoped that by utilizing a landmark as the boundary, not only will shooters now know they are in a legal shooting area, the enforcement of the boundary will be easier.

Along with the change in the congested area boundary it is important that the Washoe County citizens and visitors take steps while recreating to be as safe as possible. It is not only incumbent on shooters to make sure that while shooting in a legal area, that all precautions are made as to not unintentionally harm others in the area, but as a non-shooter how to react when encountering either legal or illegal shooting. FISCAL IMPACT

The proposed code changes are not expected to increase costs. This ordinance is exempt from the Business Impact Statement pursuant to NRS 237.060 (2)(c).

RECOMMENDATION

It is recommended that The Board of County Commissioners introduce and hold the first reading of an ordinance amending Chapter 50 of the Washoe County Code (Public Peace, Safety and Morals), amending Section 50.092 – Unlawful Discharge of Firearms; Exemption; amending Section 50.096 - Greater Truckee Meadows and environs Congested area and incorporating the Old Washoe City Congested area into the Greater Truckee Meadows and environs Congested area, 50.108 - New Washoe City Congested area; Eliminating 50.110 - Old Washoe City Congested area; to update the congested areas and associated maps; and providing for other matters properly relating thereto; and if supported, set the public hearing for second reading and adoption for July 12, 2016.

POSSIBLE MOTION

Should the Board agree with staff's recommendation, a possible motion would be: "Move to introduce and hold the first reading of an ordinance amending Chapter 50 of the Washoe County Code (Public Peace, Safety and Morals), amending Section 50.092 – Unlawful Discharge of Firearms; Exemption; amending Section 50.096 - Greater Truckee Meadows and environs Congested area and incorporating the Old Washoe City Congested area into the Greater Truckee Meadows and environs Congested area; 50.104 - Spanish Springs area Congested area, 50.108 - New Washoe City Congested area; Eliminating 50.110 - Old Washoe City Congested area; to update the congested areas and associated maps; and providing for other matters properly relating thereto; and if supported, set the public hearing for second reading and adoption for July 12, 2016."

AN ORDINANCE AMENDING CHAPTER 50 OF THE WASHOE COUNTY CODE (PUBLIC PEACE, SAFETY AND MORALS), AMENDING SECTION 50.092 -UNLAWFUL DISCHARGE OF FIREARMS; EXEMPTION; AMENDING SECTION 50.096 - GREATER TRUCKEE MEADOWS AND ENVIRONS CONGESTED AREA AND INCORPORATING THE OLD WASHOE CITY CONGESTED AREA INTO THE GREATER TRUCKEE MEADOWS AND ENVIRONS CONGESTED AREA; 50.104 -SPANISH SPRINGS AREA CONGESTED AREA, 50.108 - NEW WASHOE CITY CONGESTED AREA; ELIMINATING 50.110 - OLD WASHOE CITY CONGESTED AREA; TO UPDATE THE CONGESTED AREAS AND ASSOCIATED MAPS; AND PROVIDING FOR OTHER MATTERS PROPERLY RELATING THERETO.

THE BOARD OF COUNTY COMMISSIONERS OF WASHOE COUNTY DOES HEREBY ORDAIN:

<u>SECTION 1.</u> Through NRS 244.364 boards of county commissioners have legislative authorization to regulate through ordinances the unsafe discharge of fire arms. Washoe County has such ordinances (WCC 50.090 - WCC 50.120). The Washoe County Board of County Commissioners adopts this ordinance to add an exemption to unlawful discharge of firearms; and to update the boundaries and map for the Greater Truckee Meadows and environs Congested area, incorporating the Old Washoe City Congested area into the Greater Truckee Meadows and environs Congested area, to update the boundaries and map for Spanish Springs Congested area, to update the boundaries and map for New Washoe City Congested area, and to eliminate the Old Washoe City congested area and map.

<u>SECTION 2.</u> Chapter 50 of the Washoe County Code (Public Peace, Safety and Morals) is hereby amended by amending section 50.092 which shall read as follows:

50.092 Unlawful discharge of firearms; exemption.

1. It is unlawful for any person to:

(a) Discharge any gun, pistol, rifle, shotgun or other firearm in, on or across any county road or highway.

(b) Discharge in the unincorporated area of the county, except the Warm Springs Defined Area, any gun, pistol, rifle or other firearm, with the exception of shotguns, air rifles or B-B guns, within 5,000 feet of any dwelling occupied by another person or persons.

(c) Discharge in the unincorporated area of the county, except the Warm Springs Defined Area, any shotgun, air rifle or B-B gun within 1,000 feet of any dwelling occupied by another person or persons.

(d) Discharge any gun, pistol, rifle, shotgun or other firearm within any congested area of the county.

(i) Unless in the possession of and while lawfully hunting under authority of a valid big game tag issued by the Nevada Department of Wildlife, and then only further than 5,000 feet from any dwelling occupied by another person or persons.

(e) Hunt by the use of any means up to and including archery equipment within 1,000 feet of any dwelling occupied by another person or persons.

(ef) Discharge any firearm on a parcel in the Warm Springs Defined area within 500 feet of a dwelling located on another parcel.

2. This section does not apply to:

(a) Peace officers in the lawful discharge of duty;

(b) To persons shooting in any regularly established and lawfully authorized and licensed rifle range, gun club or shooting gallery;

(c) To any person lawfully discharging a firearm in protection of life or property.

<u>SECTION 3.</u> Chapter 50 of the Washoe County Code (Public Peace, Safety and Morals) is hereby amended by amending section 50.096 which shall read as follows:






Congested Shooting Area North

I respectfully submit this written testimony to the Board of Commissioners regarding the June 18 meeting agenda item #14, reading of ordinance amending Chapter 50; subsections 50.092, 50.096, 50.104, 50.108, and eliminating 50.110. My husband and I moved to the Horizon Hills neighborhood in August 2015 from New Mexico upon my acceptance of position at UNR as a professor. We fell in love with Reno and the neighborhood upon first sight. A key to our home purchase was the location next to Peavine Mountain and the surrounding foothills where mountain biking and hiking with our dogs fits our lifestyles very well.

We moved in on a weekday and by the first weekend noticed the target shooting, more specifically the proximity and frequency. My husband, a NRA member since 1984 and avid hunter, notably expressed concern about our safety soon after. The problem as he explained it to me, was that shooters line-of-sight and non-shooters locations in valleys below or on hillsides was "simply an accident waiting to happen" regardless of distance. Recently we learned about shooter/hiker incidents from the Facebook group "Promoting Safety on Peavine" and the proposed ordinance changes you are considering.

While my husband and I support the proposed ordinance changes, we both encourage the Washoe County Board of Commissioners to consider restricting target shooting to areas even further away. This primary reason is because the off-roading community (i.e. motorcyclists, ATV's, 4x4 trucks) that wear helmets and cannot hear shooters while operating motorized vehicles arrive on weekends, as do shooters. We believe the <u>off-road community is avoiding hikers/bicyclists in the foothill areas by operating vehicles in areas dangerously close to the shooting areas</u>. Public safety is the heart of the matter; this issue is not an affront upon our second amendment right to bear arms, the issue is seemingly an unintended consequence of Reno's growth and success.

Peavine Mountain is our central beacon landmark in our creation story. We ask the Commissioners to pass the Congested Area ordinance.









- The Washoe County Regional Shooting Facility on Pyramid Highway is open to the public for a small fee.
- Commercial indoor ranges are available in Reno/Sparks.
- There is also a high demand for free target shooting sites near Reno/Sparks.
- Recreational shooting on public land is a legitimate activity where permitted and when done safely.
- Irresponsible shooters who choose unsafe locations threaten the safety of others.

Washoe County Code 50.094 to 50.154 states that it is unlawful to discharge:

Any gun, pistol, or rifle, with the exception of shotguns, air rifles, or BB guns, within 5000 feet of an occupied dwelling.

Shotguns, air rifles, or BB guns within 1000 feet of an occupied dwelling.

• A firearm from, upon, over or across any federal or state highway or any county road or highway.

 A firearm within a Nevada State Park, unless otherwise designated by the Administrator


 Within the jurisdiction of the U.S. Forest Service, it is prohibited to discharge a firearm in or within 150 yards of a residence, building, campsite, developed recreation site or occupied area, or across or on a National Forest System road or a body of water adjacent thereto, or in a manner or place whereby any person or property is exposed to injury or damage as a result in such discharge, or into or within any cave.



Complicated rules and congested area boundaries
Unrestricted "hole" on southeast flank of Peavine Mountain shotgun, handgun, rifle, machine gun discharge allowed
Dense network of roads and trails in the "hole" (about 20 miles)
Irregular boundaries cut through trails and terrain without regard for safety

Boundaries hard for users to find and Sheriff to enforce
No point in "hole" farther than 1000 ft from a road or trail

- Most of Peavine is USFS land, but Washoe County regulates shooting through its Congested Areas ordinance (W.C.C. 50)
- Congested Area boundaries were last adjusted by the Washoe County Commission in Oct. 2002:
 - Citizens advocated expansion of Congested Area 'up to the ridge,' but a more limited expansion was approved. Commissioner Galloway "said he believes the expansion is adequate, but if it proves not to be, action could be taken later to address the situation."
- Boundaries based on distances from developments and structures
- Trails and usage have increased greatly since 2002
- Boundaries don't make sense with locations and current usage of trails and roads



Action Plan

- Past and current efforts have failed to ensure safety
- Need to improve safety and meet the needs of responsible hikers, bikers, runners, dirt-bikers, 4x4ers, and target shooters
- Multi-prong effort:
 - More Education
 - Better Enforcement
 - Smarter Regulation

More Education

- Improve signage with a consistent and simple message about where shooting is restricted and where it is allowed.
- Continue efforts by the Sheriff's Office and user groups to educate the public about the Congested Areas and restricted shooting areas.
- Need effort to train shooters on basic firearms safety.
- Educate trail users on protocols to protect their safety when they encounter shooting that is too close for comfort.

Better Enforcement

- Increase patrols in the area by an OHV officer
 OHV ranger previously funded by USFS
 - authority to enforce shooting regulations
 - focus on education and warnings rather than citations for most
 - Citations for repeat offenders and those in open defiance of regulations
- Promote accurate and timely reporting of illegal and unsafe shooting
 - outreach to trail users on keeping safe and reporting protocols

Smarter Regulation

- Adjust and simplify Congested Area and Restricted Shooting boundaries
 - Protect areas with dense trail and road networks
 - Provide safe legal shooting areas to attract shooters away from trails and Congested Areas
 - Boundaries should follow easily identified geographic features or roads

Smarter Regulation

(continued)

- Prohibit shooting over and toward trails and roads
 - Carson City District of BLM currently has this regulation
 - USFS, County, and State regulations prohibit shooting from or over official roads and highways, but do not explicitly mention "trails"
- Establish mechanism for an organized group of responsible shooters to adopt and maintain safe, sustainable shooting areas


Action Now

- County staff and Sheriff's Office can work with Peavine Trail Safety and other user groups
- Washoe County Board of County Commissioners (BCC) needs to act to change Congested Area boundaries and shooting restrictions








Alternative 2 Expand Congested Area to all of East Peavine



 - Prohibit shooting at glass targets (e.g., televisions or bottles), targets on trees, or at trees.
 - Prohibit shooting across or towards roads, trails, and military ranges.
- USFS could assimilate county code by Forest Service Order (to include Congested Area restrictions)

Max via e-mail (incident on 3/26/2016: "My family and I live adjacent to the Peavine open space at the top of Sunline and Sandestin Drive in NW Reno. We enjoy hiking out on Peavine all the time, having lived there 10 years. We hear people shooting all the time, sometimes in the middle of the night.. or too close to the house. But I've never had a problem like the one I had Saturday. On Saturday morning [March 26], me, my two daughters (10 and 11), and my dog decided we would finally hike to the top of Peavine from the house for the first time. We started due North from Sunline and Sandestin. As we turned East to approach the road that comes up from North Virginia, we entered a canyon with steep sides on both the left and right. We could hear someone shooting, and the sounds were echoing around the canyon. That's when my daughter says "It sounds like they are shooting over our heads." I say, "no one would be that stupid to shoot over the trail." Then we hear, and feel, the sound of a rifle shot whiz past our heads.. and we could see the boulder about 40 yards forward and to our left get struck by a bullet. The dust clouds of the strikes were clear. After ducking for cover, we began to holler to get the shooter's attention. He was on the ridge to the South, shooting over the canyon and trail, aiming at targets on the North side of the canyon. We hollered and hollered, but could not get the shooter's attention, and never were able to see the shooter. Unfortunately, we had to retreat back down the hill and call our hike short of reaching the top. We were deeply disappointed with the lack of sensibilities demonstrated by this shooter or shooters. We called 911 and reported the incident. I'm saddened to think that I need to carry a whistle, and wear bright orange to enjoy the mountain behind my home." [The location of this incident was very near the northern border of the Congested Area, but south of the main Peavine Road.]

From Ben: I want to send you a few photos I took that I feel highlight the issues with legal shooting on Peavine. I came across a couple of young men shooting directly over and across a popular mountain bike trail called Scrub Brush Trail.





The problem in my opinion is that these individuals were shooting LEGALLY, in the "donut hole". I think it is the perfect example of how a growing trail network should not exist in a legal shooting area. The green arrow is the trail and the red arrow is the direction of shooting. I also attached a photo I took of some friends running on this exact trail about a month earlier. Where they are would be directly in gunfire yesterday, kinda scary. [08/15]







Ben (FB 1/2015) shared this photo of shot-up target debris directly on singletrack trail above Keystone Canyon: "I had a run in here with target shooters that had to stop shooting and lower their guns so I could pass. ... They were using handguns when I came upon them, but they also had an arsenal laid out on their tailgate. I told them about the popularity of the trail they were shooting across and they agreed to move somewhere else. The thing that scares me about this location is that the trail wraps down around a spot where people shoot clay pigeons. In my opinion it is the perfect example of trail crossing straight through a shooting range at a very close proximity in a prohibited area."



I made a detour to avoid the cross fire. People coming from the other direction would never have known.

First, Thank you for pursuing a safer Peavine. I am an avid trail runner on Peavine who runs to the summit and all around it weekly. I've had 3 close calls this year, with one being just yesterday. I was running up Robb Canyon very close to the house and had bird shot from a shotgun rain down all around me as I was going up the trail. Fearing others may get hit I hiked directly to the shooters and let them know of their proximity to the trail and that they were showering it with shotgun shots. I feel strongly that something needs to change.

We came across two groups of shooters on the lower third of Peavine yesterday, both of which were shooting towards or over roads. There were a lot of people out and each group showed varying awareness of other users in the area. Changes should be made. I certainly don't want to be shot or hit by clay debris because I decided to spend my Saturday in Reno's backyard.

Out on a ride around Peavine this afternoon. Heard major blasting over the horizon in front of me. Big gun. And then the ricochet whizz off my left, approx ear level. I hit the deck and went a little ballistic w whistles and fbombs. Shooting stopped. I asked them to let me pass, which they did. Kinda put a damper on an unbelievable spin in the hills. This issue won't be addressed until someone is hit. That's a real shame. Peavine riders beware

I run by myself up there every week and see thousands of shell casings and other "target" trash. It disgusts me. I hear shooting all the time across the trails which isn't supposed to be happening. What can we do to stop this? Will nothing get done til someone gets shot? Stone P. @ Facebook.com, 12/27/2014

"... we, my dog and/or wife, have been out at Peavine hiking, and mountain biking, and had to turn around because of the gun fire. SO tired of it! It's is way too congested and unsafe for everyone. I remember around Thanksgiving last year, a very nice, warm day, about 15 mtn bikers+ numerous hikers out there and there were two groups one just off of the boundary road off Keystone, and another to the north about 1/2 mile north, shooting while all of these other people with their dogs were out trying to enjoy the day. Once again, we turned around. Too unsafe. What a disappointment when I called the sheriff's office to report it, and said there was nothing they could do because we were past the Keystone fence/road. It was considered BLM? land."

- rarecj8 @ reno4x4.com, 12/2014: "There is the 10% element in any user group that are not concerned with any rules or safe conduct. I've come down the main service road and around a corner came upon several rows of wine bottles standing ditch to ditch. And just below there parked on the road, lawn chairs and tables, two trucks with two couples all in their mid 60s. Seemed like normal folk, other than their choice for a shooting lane right on the road and complete unawareness of of the safety implications, not to mention the restrictions. With a nice attitude i spoke with them and it was like 'we never knew' and the packed up and m over on."

(All Commission Districts.)

Commissioner Jung,

Our subsidiary, American Towers, LLC, owns the radio tower property at the summit of Peavine Peak (10125 Peavine Peak Road, Reno, Nevada), which is adjacent to Forest Service land and other private parcels. American Tower Corporation (ATC) hereby submits the following comments as input for consideration in the upcoming discussion regarding the proposed Washoe County Code Amendment affecting Chapter 50.

- 1. We fully support the Washoe County strategic objective to provide safe, secure and healthy communities.

We recognize that with the successful growth and development of the local communities, there is an increased presence of people involved in recreational activities such as running, hiking and biking in throughout the multiple recreational trails and roadways.
