SUBJECT: Request that the Board of County Commissioners retroactively acknowledge the grant award from the State of Nevada, Administrative Office of the Courts to the Second Judicial District Court, in the amount of \$1,163,448 (no match required), to support the Specialty Court programs, effective July 1, 2016 through June 30, 2017, and direct the Comptroller's Office to make the necessary budget amendments. (All Commission Districts)

#### **SUMMARY**

The Second Judicial District Court has been awarded \$1,163,448 in grant funding to support existing and newly-funded Specialty Court programs. This award will be used to help fund the Adult Drug, Diversion, Veterans, Felony DUI, Family Drug, Family Mental Health, Mental Health, Medication Assisted Treatment, and Youth Offender Drug Courts. The costs to the Court associated with serving these populations include substance abuse and mental health treatment, drug testing, operational expenses, salaries and benefits for District Court's Specialty Court staff, bus passes, and incentives.

## **PREVIOUS ACTION**

No previous Board action.

#### **BACKGROUND**

This grant award for fiscal year 2017 includes a State of Nevada general fund appropriation and funding made available through the 2003 passage of Assembly Bill 29 (NRS 176.0613). These funds are distributed by the Administrative Office of the Courts (AOC), and awarded to each District, statewide. A requirement of any Court receiving AOC funds is that they comply with best practices and specific criteria outlined in Nevada Specialty Court Funding Guidelines and Criteria, as established by the Specialty Court Funding Committee and approved by the Judicial Council of the State of Nevada.

The 78<sup>th</sup> session of the Nevada Legislature provided a general fund appropriation of three million dollars each year of the biennium to enhance specialty court programs. The Administrative Office of the Courts sent a request for applications in April 2016 to each participating District statewide to submit applications for new or existing Specialty Courts for fiscal year 2017. The Second Judicial District Court applied for and was awarded funding for its existing Youth Offender, Medication Assisted Treatment, and Northern Nevada Regional Mental Health Courts, for the period July 1, 2016 through June 30, 2017, in the amount of \$244,296.

Assembly Bill 29 (NRS 176.0613) established the State of Nevada Specialty Court Funding Committee in 2003. Since that time, the Committee has overseen the application process, set standards for funding criteria, and makes recommendations to the Statewide Judicial Council for the distribution of funds. The Second Judicial District Court has received grant funding each year through the AB29 appropriation for Adult Drug, Diversion, Family Drug, Family Mental Health, Felony DUI, Mental Health, and Veterans Courts. The AOC has awarded the Second Judicial District Court \$919,152 for fiscal year 2017 for these Courts.

## **GRANT AWARD SUMMARY**

Project/Program Name: Second Judicial District Court's Specialty Courts.

Scope of the Project: The Second Judicial District Court will contract with community providers for substance abuse and mental health treatment and drug testing as well as pay for costs associated with operational expenses, salaries and benefits for District Court's Specialty Court staff, bus passes, and incentives.

Benefit to Washoe County Residents: The goal of Specialty Courts is to assist the substance abusing defendants in becoming productive members of society, through abstaining from any further illicit drug use and preventing recidivism.

**On-Going Program Support:** These funds are made available through the Administrative Office of the Courts and will support the Second Judicial District Court's needs in providing professional services for its Specialty Courts and to maintain compliance with the funding criteria and drug court best practices. These programs rely on annual grant funding from the AOC.

Sub-Awards and Contracts: The Second Judicial District Court will contract with Northern Nevada HOPES (Youth Offender Court) in the amount of \$30,000, Quest Counseling and Consulting (Medication Assisted Treatment Court) for counseling services, in the amount of \$156,154 and Rocky Mountain Offender Management Systems (Adult Drug, Diversion, Family Mental Health, Youth Offender Drug Courts) for drug testing services, in the amount of \$299,097. Based on the selected vendor, who is yet to be determined, the Court will also contract with a local provider for substance abuse counseling services for Adult Drug and Family Drug Courts.
