On August 9, 2016 the Washoe County Board of Commissioners approved the Health Benefits Program for Calendar Year 2017 to include a new Self-Funded High Deductible Health Plan with Hometown Health acting as the Third Party Administrator (TPA), which will provide access to Renown Hospital and the Hometown Health Self-Funded Provider Network.
