# **SUMMARY**

Acknowledgement of Publication of Notice of Intent to Augment Budget and approval of the attached resolution to augment the General Fund in the amount of \$1,096,211 for appropriation authority for previously approved but unbudgeted expenditures for Fiscal Year 2016-17.

Washoe County Strategic Objective supported by this item: Stewardship of our community

## PREVIOUS ACTION

May 17, 2016: Board of County Commissioners (BCC) approved the Fiscal Year 2016-17 final budget.

In most years there is a difference between the actual audited ending fund balance of one fiscal year and the budgeted beginning fund balance of the subsequent fiscal year, which is excess beginning fund balance, also known as carryover. This amount is available for one-time purposes such as unanticipated capital expenses or other increases needed for anticipated cost overruns. If the Board chooses not to process a mid-year augmentation, these monies remain in the General Fund's balance and are available in future years.

It is recommended that a portion of the carryover from Fiscal Year 2015-2016 available for Fiscal Year 2016-2017 be used for the following unbudgeted funding requirements:

- 1) The Justice Courts collect administrative assessments that have 2- and 5-year expirations on their use. A total of \$60,525 of unused administrative assessments for Wadsworth and Sparks Justice Courts was transferred to these court's General Fund budgets in Fiscal Year 2015-16 and requires a carryover appropriation for use in Fiscal Year 2016-17. Incline Village Justice Court did not have any balance of administrative assessments. Expired administrative assessments collected by Reno Justice Court are not re-appropriated because these assessments covered a portion of staff costs in the previous fiscal year.
- 2) An additional \$985,275 is requested to augment the Sheriff's Office (WCSO) salaries and benefits budget. During the Fiscal Year 2016-17 budget process, labor agreements were still in the process of being negotiated. Therefore, the full amount of the 3.0% COLA later approved, plus changes to various shift differentials and special pays, was not fully included in this fiscal year's budget. Due to vacancies so far this year, many departments have been able to absorb the unbudgeted portion of these labor increases, but the Sheriff's Office requires additional budget authority.
- 3) An additional \$50,211 is requested to augment the District Court's budget for additional Pre-Trial Services Officers related to the implementation of the Nevada Pretrial Risk Assessment (NPR) and the process pertaining to judicially imposed bail, which supports the NPR. This augmentation will provide funding for 2.0 FTE's through the remainder of Fiscal Year 2016-17, as well as additional personnel costs incurred to date.

### **FISCAL IMPACT**

If approved, the augmentation for carryover will result in an increase in appropriations for the General Fund of \$1,096,211, which will be appropriated in the following accounts:

# RESOLUTION TO AUGMENT THE BUDGET OF THE WASHOE COUNTY GENERAL FUND

WHEREAS, the Washoe County General Fund has sufficient available resources consisting of a an opening fund balance of \$53,438,599 which is greater than the beginning fund balance of \$44,611,066 budgeted in Fiscal Year 2016-17; and

WHEREAS, the Washoe County General Fund has the need for appropriation authority for unbudgeted expenditures; and

WHEREAS, the Washoe County General Fund also has sufficient cash to meet these additional expenditures; and

WHEREAS, total resources of the General Fund of Washoe County were originally budgeted to be \$318,403,323 on July 1, 2016 and were augmented to be \$318,545,226; and

WHEREAS, the total available resources are now determined to be \$319,641,437; and

WHEREAS, said additional available resources are an opening balance for Fiscal Year 2016-17 which was larger than anticipated, of which \$1,096,211.00 is now appropriated.

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners of the County of Washoe, State of Nevada:

Section 1. That the budget of the Washoe County General Fund be adjusted as follows:
