## **BACKGROUND**

In accordance with the provisions of NRS 332.039, the Washoe County Purchasing Division advertised and solicited bids for Solenoid Operated Dead Latch System.

The Invitation to Bid was duly advertised in the Reno Gazette-Journal and made available thru the online services of Demandstar.com, resulting in the receipt of two (2) bids.

#### **BACKGROUND CONTINUED:**

Sealed bids were opened in the Washoe County Purchasing Office on January 25th, 2017. Western Detention bid an alternate product, which was deemed an acceptable alternative by the County.

## **FISCAL IMPACT**

Funds for the Solenoid Operated Dead Latch System have been approved as part of the FY16/17 Capital Improvement Plan. Budget authority in the amount of \$250,000 exists in Fund 402, Project PW920482.
