SUBJECT: Approve an amendment to increase FY17 budget authority in the amount

of [\$6,750] in both revenue and expense to the Continuum of Care – Shelter Plus Care 2014 award period August 1, 2016 to July 31, 2016, IO 11268; and if approved direct the Comptroller's office to make the

appropriate budget amendments. (All Commission Districts)

SUMMARY

The Department received a Continuum of Care Grant Agreement Renewal from the United States Department of Housing and Urban Development (HUD) to provide housing and supportive services to homeless individuals in our community.

Washoe County Strategic Objective supported by this item: Safe, Secure and Health Communities.

PREVIOUS ACTION

On October 27, 2015, the Board accepted agenda item 9, the 2014 Continuum of Care Agreement Renewal in the amount of \$113,171 (up to \$52,896 County match) retroactive to August 1, 2015 through July 31, 2016 for fiscal year 2016.

BACKGROUND

Funding from this award will be used to provide housing and supportive services to homeless individuals in our community.

The FY16 Continuum of Care (SPC) Budget was adopted on October 27, 2015 in revenue and expense. At FY16 year-end close there was approximately \$20,518.92 in remaining budget authority in internal order 11268. The department requests to carry forward \$6,750 of this amount into FY17 to ensure sufficient budget authority exists through June 30, 2017 to cover all allowable grant expenditures.

FISCAL IMPACT

Should the Board approve these budget amendments, the Department's adopted FY17 budget will be increased by \$6,750 in both revenues and expenditures in the following accounts:

RECOMMENDATION
