SUBJECT: For possible action to reappoint Sarah Chvilicek to the Truckee Meadows

Regional Planning Commission for a term beginning July 1, 2017, and ending June 30, 2020, or until such time as Ms. Chvilicek no longer serves on the Washoe County Planning Commission or a successor is appointed,

whichever occurs first. (All Commission Districts.)

SUMMARY

Sarah Chvilicek's term on the Regional Planning Commission (RPC) will expire on June 30, 2017. The Washoe County Board of Commissioners (Board) is being asked to reappoint Ms. Chvilicek to a 3-year term on the RPC. If reappointed, the term will begin on July 1, 2017, and end on June 30, 2020, until such time as Ms. Chvilicek no longer serves on the Washoe County Planning Commission or a successor is appointed, whichever occurs first.

Washoe County Strategic Objective supported by this item: Stewardship of Our Community.

PREVIOUS ACTION

On June 9, 2015, The Board appointed Sarah Chvilicek to the RPC to fill an unexpired term beginning July 1, 2015, and ending June 30, 2017.

BACKGROUND

Pursuant to NRS 278.0262, the Board appoints three members from the Washoe County Planning Commission (PC) to represent Washoe County on the RPC. RPC member terms of office are three years. Pursuant to NRS, at least two of the members must be residents of the unincorporated County. Since all PC members are unincorporated County residents, this requirement is fulfilled. RPC member terms are three years in length and are staggered. At the present time, the Regional Planning Commissioners representing Washoe County are:

Ms. Chvilicek is serving a first full term on the Planning Commission which will expire on June 30, 2019. She will be eligible for reappointment to a second full term on the PC. If reappointed to the PC, her new term will expire on June 30, 2023; therefore, she will be able to serve the requested full three-year term on the RPC.

Should the Board agree with staff's recommendation, the Regional Planning Commissioners representing Washoe County would be:

FISCAL IMPACT

Regional Planning Commission members are compensated at a rate of \$80.00 per meeting pursuant to NRS 278.0262(4). The RPC typically meets six times a year, which equates to an annual stipend of \$480 per member. Funds to compensate Washoe County appointed RPC members for scheduled meetings are included as part of the FY 2017-2018 budget of the Planning and Development Division, Community Services Department (Account 105400-710110).

RECOMMENDATION

It is recommended that the Board reappoint Sarah Chvilicek to the Truckee Meadows Regional Planning Commission for a term beginning July 1, 2017, and ending June 30, 2020, or until such time as Ms. Chvilicek no longer serves on the Washoe County Planning Commission or a successor is appointed, whichever occurs first.

POSSIBLE MOTION

Should the Board agree with staff's recommendation, a possible motion would be: "Move to reappoint Sarah Chvilicek to the Truckee Meadows Regional Planning Commission for a term beginning July 1, 2017, and ending June 30, 2020, or until such time as Ms. Chvilicek no longer serves on the Washoe County Planning Commission or a successor is appointed, whichever occurs first.."
