
Washoe County Strategic Objective supported by this item: Safe, Secure and Healthy Communities.

### PREVIOUS ACTION

Prior OCDETF funding was approved by the Board on October 14, 2014, March 22, 2016, and June 28, 2016.

### BACKGROUND

The Washoe County Sheriff's Office participates in the Organized Crime Drug Enforcement Task Force. Funds are allocated to cover overtime expenses associated with the investigation of specific initiatives. Reason for retroactive submittal: The above award amount is the preliminary amount allocated, actual true amount of time billed to date and projections through 9/30/2017 for this funding based upon current case activity.
