SUMMARY

Amends Washoe County Code Chapter 100 (Building and Construction, Article 100.100.10) to adopt the 2018 versions of the International Building Code; International Residential Code; International Existing Building Code; International Energy Conservation Code; Uniform Plumbing Code; Uniform Mechanical Code; International Mechanical Code; International Fuel Gas Code; International Wildland-Urban Interface Code; International Swimming Pool and Spa Code; the 2018 National Fire Protection Association 54 and the 2017 58 Code; the 2017 National Electrical Code; together with the 2018 Northern Nevada Amendments by the Northern Nevada Chapter of the International Code Council; and, other matters relating to the provisions of Chapter 100, effective July 1, 2019.

WHEREAS on October 18, 2018, the Northern Nevada Chapter of the International Code Council published the 2018 Northern Nevada Amendments to the 2018 International Building Code; 2018 International Residential Code; 2018 International Existing Building Code;

2018 International Energy Conservation Code; 2018 International Fuel Gas Code; 2018 International Mechanical Code; 2018 Uniform Mechanical Code; 2018 Uniform Plumbing Code; and the 2017 National Electric Code; and

WHEREAS on November 13, 2018, the Washoe County Board of Commissioners approved initiation of amendments to Washoe County Code (Building and Construction, Chapter 100.100.10) to adopt the current codes together with supplements, listed changes, additions and deletions, and other matters relating to the provisions of Chapter 100, to become effective July 1, 2019.

NOW THEREFORE, THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF WASHOE DO ORDAIN:

<u>SECTION 1:</u> Section 100.100.10 of the Washoe County Code is hereby amended to read as follows:

SECTION 2 General Terms.

1. <u>Business Impact Note.</u> This is not a "rule" within the meaning of NRS 237.030 – 237.150 (Adoption of Rules Affecting Businesses) because it is an ordinance adopted pursuant to NRS Chapter 278.

- 2. <u>Validation of Actions.</u> Notwithstanding any defects or irregularities, all actions, proceedings, matters and things heretofore taken by the board of county commissioners and its agents or the officers, employees and contractors of the County purportedly had or taken under law or under color of law by any of them which actions, proceedings, matters and things are not inconsistent with the provisions of this Ordinance are ratified and approved.
- 3. <u>Implementation; edits.</u> The Chairman of the Board and the officers of the County are authorized and directed to take all action necessary or appropriate to effectuate the provisions of this ordinance. The District Attorney is authorized to make non-substantive edits and corrections to this Ordinance.
- 4. <u>Repealer.</u> All ordinances, resolutions, bylaws and orders, or parts thereof, in conflict with the provisions of this ordinance are hereby repealed, but only to the extent of such inconsistency. This repealer shall not be construed to revive any ordinance, resolution, bylaw or order, or part thereof, heretofore repealed.
- 5. <u>Publication and Effective Date.</u> This ordinance shall be executed and its title shall be published as required by NRS 244.100, NRS 244.105, and any other enabling laws, and shall be effective on the date specified below.
- 6. <u>Severance of Invalid Provisions.</u> Each term and provision of this ordinance shall be valid and shall be enforced to the extent permitted by law. If any term or provision of this ordinance or the application thereof shall be deemed by a court of competent jurisdiction to be in violation of law or public policy, then it shall be deemed modified, ipso facto, to bring it within the limits of validity or enforceability, but if it cannot be so modified, then it shall be excised from this ordinance. In any event, the remainder of this ordinance, or the application of such term or provision to circumstances other than those to which it is invalid or unenforceable, shall not be affected.
